The Village of Bradley Household Pre-paid Cards will have a tiered structure based on residency in 2022. **You must be a current resident to qualify.** The tiers are: \$30 (1-90 days), \$60 (91-180 days), \$90 (181-270 days), and \$120 (greater than 271 days). Household Pre-paid Cards are limited to one (1) per household. In order to determine if you qualify for a Pre-paid Card, please complete an application, and attach a copy of your proof of residency, then submit to:

Process for the Household Pre-paid Card Rebate

1. Complete and return application to the Village of Bradley.
2. Village receives and verifies application.
3. The Village contacts qualified applicants and schedules pick-up of Pre-paid Card.
4. Pre-paid cards will be released in batches, at the announced location (provided in step 3).
5. Valid Photo identification is required to pick-up Pre-paid Cards.
6. Upon receipt, the pre-paid card must be activated. (Instructions provided with Pre-paid Card)
