Chairman Hernandez called the regular meeting of the Bradley Police & Fire Commission to order on Monday, June 1, 2009 at 6:00 p.m.

Roll call was taken, present were Chairman Hernandez, Secretary Arrington and Commissioner Gonczy. Also present were Police Chief Steven E. Coy, Fire Chief James Baird, Teresa M. Richert, Administrative Assistant to the Police Chief and Village Trustee George Golwitzer.

A motion was made by Chairman Hernandez and seconded by Secretary Arrington to accept the minutes of the May 3, 2009 Regular meeting. A roll call vote was taken (2 Ayes 1-Abstain Nays) Motion carried.

CORRESPONDENCE/COMMUNICATION:

Chief Coy stated that the Police Department is now at 28 Officers and we need more. The department is short 4 Sergeants, we don't even have 2 Sergeants per all shifts. The current Lieutenant list expires 10/9/09. We have 6 eligible Sergeants that my want to test. We will investigate costs and time frame.

A motion was made by Secretary Arrington and seconded by Chairman Hernandez to maintain a current Lieutenant Eligibility Promotion list as our list expires in September 2009. A roll call vote was taken: (3 Ayes 0 Nays) Motion carried.

Chief Baird gave the results of the Oral Interviews for applicants. The Chief submitted a list of applicants that have passed the second phase of testing and the completed eligibility list for our approval.

A motion was made by Chairman Hernandez and seconded by Commissioner Gonczy to accept the final Eligibility for the Fire Fighters presented by Chief Baird. A roll call vote was taken: (3 Ayes 0 Nays) Motion carried.
