A motion was made to adopt O-07-23-07 An Ordinance Amending Chapter 34 (Peddlers and Solicitors), Article II (Commercial Solicitor's License), Division II Section 34-79 (Issuance) and Section 34-81(Disqualification) of the Bradley Village Code by Trustee Billingsley and seconded by Trustee Vandenhout (6 ayes 0 nays) Motion carried

NEW BUSINESS


Mayor Watson nominated Scott Williams as the new Public Works Director.
