Mayor Watson stated that the payment for the Downstate Stabilization Grant for the Village of Bradley awardees has arrived. He stated the Village applied for 28 Bradley Businesses for a total of \$680,000 however, the state was only able to award our village a total of \$324,000 for 16 of our businesses. Mayor Watson also noted that Bradley was the only municipality in Kankakee County to apply for this grant for their small businesses. Mayor thank Deputy Clerk Nelson, Community Development Director Page and team for doing a great job in assisting our local businesses with this grant. He said that grants are a team effort.
