## **NEW BUSINESS:**

The Rules and Regulations of the Board of Fire and Police Commissioners in the Village of Bradley will be affective on 10/6/2020 which is 10 days after the Notice of Publication was published in the Kankakee Daily Journal.

Chairman Golwitzer explained that the process for Police Officer application and testing had experienced some delays but it is now continuing and progressing as expected. Once the application is finalized, it will be posted to the applytoserve.com website and the application deadline will be Friday, 11/20/2020 at 4 p.m. Online testing will be conducted from 9 a.m. Wednesday, 12/2/2020 through Saturday, 12/5/2020 at 4 p.m.

The results of the Firefighter oral interviews were reviewed by the Commissioners and a Firefighter Initial Eligibility Register was established. Secretary Arrington made a motion to approve the Firefighter

Initial Eligibility Register and Commissioner Hernandez seconded the motion. Roll call (3 ayes, 0 nays). Motion carried.

Chairman Golwitzer will send e-mails tomorrow (Tuesday, 10/6/2020) to all candidates on the Firefighter Initial Eligibility Register detailing the process for Firefighter preference point claims which will be due in 10 days (Friday, 10/16/2020). Once the preference point claims are received, the Commissioners will convene a Special meeting to establish a final Firefighter Eligibility Register.
