The regular meeting of the Bradley Village Board was called to order on Monday, November 13, 2017 at 6:30 p.m. at the Bradley Municipal Hall. President Adams presided. Roll call: Trustees Balthazor, Redmond, Gadbois, Watson, Dugan-Roof and Barber. All Trustees were present.

AGENDA

- Chief Johnston noted that the Honor Guard from Bradley went to Washington DC to take part in a Memorial Service at the Law Enforcement Memorial Wall in DC. He then presented Laurie Lewis with a photo and an inscription of Will's name on the Memorial wall.
- Mayor read an article regarding the Bradley Christmas Parade, parade will be Friday, December 1, 2017 the theme is "Christmas Through a Child's Eyes". The committee is asking for street closures for the parade.

- No parking on Broadway between Michigan and Wabash.
- No parking in the 100 & 200 blocks of North Forest and all four blocks of South Forest after 4 p.m. on Friday.
