R-11-18-4 a Resolution approving a Qualification-Based Selection Policy for the Village of Bradley, Kankakee County, Illinois

A motion was made to adopt R-11-18-4 by Trustee Gadbois and seconded by Trustee Allen (6 ayes 0 nays) Motion carried It was noted that on Page 1 of the Resolution there is a paragraph that stated the Village previously submitted a copy QBS Policy to the Illinois Department of Transportation. IDOT has approved QBS policy when in fact IDOT has not approved the policy. Trustee's Gadbois and Allen amended their motion and second to a re-vote and removed the "whereas" in the first page of the Resolution.

A re-vote was taken (6 ayes 0 nays) with the elimination of the paragraph.

### **INSURANCE, FINANCE & APPROPRIATIONS**

A representative from the audit firm Lauterbach & Amen was present; he gave the Financial Audit and Management letter for years ending April 30<sup>th</sup> 2017 and 2018 and the State Route 50 Financial report. The representative stated he would center on the April 30 2018 Audit.

Total fund balance was \$10,000,000

Income sheet it was noted \$955,000 deficit

Recommend that in accounts FDIC only insures \$250,000 and we have more money in that these accounts need to be collateralized to cover the added amount over the \$250,000.
