Chairman Golwitzer called the Regular meeting of the Bradley Fire & Police Commission to order on Tuesday, December 13, 2022, at 4:35 p.m.

Stanard and Associates was unable to provide the Police Officer Candidate written test results in time for this meeting. Jade Raines has successfully completed the conditional offer of employment requirements and is scheduled to be sworn in as a full-time firefighter Bradley Village Board Meeting on Tuesday, 12/27/2022.

No veteran's preference points were claimed by the candidates on the Fire Lieutenant Preliminary Promotional list so no updates to the final list were

The 2023 Village of Bradley Fire and Police Commission meeting schedule was reviewed. A motion was made by Secretary Arrington and seconded by Chairman Golwitzer to approve the schedule as presented. Roll call (2 ayes, 0 nays). Motion carried.
