UTILITIES/EXPANSION

POLICE & FIRE DEPARTMENT

Trustee Gadbois reported the Police & Fire Committee met on Thursday, December 13, 2018. The report is available on the Village website.

Fire – First order of business, Captain Goudreau presented the committee with a bid for another Thermal Imaging Camera for a third vehicle. This is a budgeted item: budget line is \$10,000 – Air One Equipment bid is \$7,999.00. This is the exact same brand as the other two cameras currently used by the department. Second item, which is a budgeted item at \$9,000, the department did receive two bids: Gear drying system – currently the department is drying the gear with a hose dryer. This was discussed during the budget process.

- Air One Equipment \$7,995

The department recommended Haiges Machinery the Committee voted (2-0).

Police – Chief Johnston shared with the committee about the 10 Shared Principles from the NAACP and the Illinois Association of Chiefs of Police. Chief also reported that almost 1,000 books have been donated to the department, that will be shared with other departments and programs in the county. Chief Johnston brought up to the Board that Staff & Command is approaching, the approximate expense would be \$4000.

A motion was made by Trustee Gadbois and seconded by Trustee Allen to approve the cost for an Officer to attend Staff & Command training. (6 ayes 0 nays) Motion carried
