REGULAR MEETING MINUTES

Chairman Golwitzer called the Regular meeting of the Bradley Fire and Police Commission to order on Monday, December 2, 2024, at 6:00 p.m.

IN ATTENDANCE:

Chairman Golwitzer, Secretary Arrington, Commissioner Glidewell and Fire Chief Kaderabek.

PUBLIC COMMENT: None

REVIEW/APPROVAL OF MINUTES:

A motion was made by Secretary Arrington and seconded by Commissioner Glidewell to approve the November 4, 2024, regular meeting minutes and the November 16, 2024 special meeting minutes. Roll call (3 ayes, 0 nays). Motion carried.

CORRESPONDENCE/COMMUNICATION:

Firefighter candidates Brad Senesac and Greg DeVries submitted their signed letter of acceptance for the conditional offer of employment as a full-time firefighter.

APPROVAL OF BILLS:

A motion was made by Chairman Golwitzer and seconded by Commissioner Glidewell to approve the \$400 invoice from Conrad Polygraph for firefighter pre-employment polygraph exams (#6336), \$990 invoice from Stanard and Associates for firefighter pre-employment psychological exams (#59763) and the \$7,150 invoice from Stanard and Associates for the 2024 Police Lieutenant promotional process (invoice 1 of 2 #59758) . Roll call (3 ayes, 0 nays). Motion carried.

UNFINISHED BUSINESS: None.

NEW BUSINESS:

Chairman Golwitzer updated the commissioners on the Police Lieutenant promotional process preparation. Current register expires 4/4/2025. The written test and assessment center need to be completed in first half of March 2025.

Chairman Golwitzer reviewed the status of the firefighter application submittals. 1 candidate has applied for the position to date. The application deadline is 1/10/2025. The online written exam will be taken between 1/22/2025 and 1/24/2025.

Chairman Golwitzer reported that the website link for the lateral police officer applications was launched today. The application deadline is 1/24/2025.

A motion was made by Chairman Golwitzer to enter into Executive session per 5ILCS120/2c1. The motion was seconded by Secretary Arrington. Roll call (3 ayes, 0 nays). Motion carried. Executive session was entered at 6:08 p.m.

During the executive session, the commission reviewed the background investigation results, polygraph results, medical exam results, psychological evaluations, physical agility exam results and employment applications for firefighter candidates Brad Senesac and Greg DeVries who were both given conditional offer of employments for a full-time firefighter position. The executive session was exited at 6:48 p.m. after the reviews were completed.

A motion was made by Secretary Arrington and seconded by Commissioner Glidewell to approve hiring Brad Senesac and Greg DeVries as full-time firefighters. Roll call (3 ayes, 0 nays). Motion carried.

The Commission has not received authorization to promote a firefighter to Fire Lieutenant.

With no other business to discuss, a motion was made by Chairman Golwitzer and seconded by Commissioner Glidewell to adjourn the meeting. Roll call (3 ayes, 0 nays). Motion carried. Meeting adjourned at 6:55 p.m.
