Chairman Golwitzer called the Regular meeting of the Bradley Fire & Police Commission to order on Monday, December 6, 2021, at 6:00 p.m.

IN ATTENDANCE:

REVIEW/APPROVAL OF MINUTES:

A motion was made by Commissioner Glidewell and seconded by Chairman Golwitzer to approve the November 1, 2021, Regular meeting minutes. Roll call (3 ayes, 0 nays). Motion carried.

CORRESPONDENCE/COMMUNICATION: None

APPROVAL OF BILLS:

The commissioners reviewed the Stanard and Associates invoice (1 of 2) of \$5,784.01 for the Police Lieutenant Promotional Process. A motion was made by Commissioner Glidewell and seconded by Chairman Golwitzer to approve the bill. Roll call (3 ayes, 0 nays). Motion carried.

UNFINISHED BUSINESS: None

NEW BUSINESS:

The commissioners reviewed the status of the Police Lieutenant Promotional testing preparation. Stanard and Associates worked with Police Chief Barber to create a written exam study guide. This study guide is being distributed to all eligible candidates. They will conduct a candidate orientation Zoom session with the candidates taking the exam. The session will be recorded and a link will be shared with those candidates who could not attend the session. Chief Barber will work with Stanard and Associates to schedule the Zoom session. The written exam administration has been scheduled for February 1<sup>st</sup> and the Assessment Center is scheduled for February 8<sup>th</sup>.

Chairman Golwitzer reported that there has been no change in the status of the conditional offers of employment given to two firefighter candidates. Both conditional offers are dependent on the candidates being issued an EMT-Paramedic License by the Illinois Department of Public Health (IDPH) by their respective deadlines. Candidate Dan Hill's conditional offer expires on December 31, 2021 and candidate Cody Reinbold's conditional offer expires on March 31, 2022.

Chairman Golwitzer reported there are ten candidates that have submitted applications for the next Firefighter on-line written exam scheduled for December 15<sup>th</sup> through December 18<sup>th</sup>. The status of

each applicant was reviewed and feedback/direction was given to Stanard and Associates on the actions to be taken for those candidates missing information.

The proposed 2022 Regular Fire and Police Meeting schedule was presented and reviewed. A motion was made by Commissioner Glidewell and seconded by Secretary Arrington to approve the 2022 meeting schedule. Roll call (3 ayes, 0 nays). Motion carried.

With no further business to discuss, a motion was made by Commissioner Glidewell and seconded by Secretary Arrington to adjourn the meeting. Roll call (3 ayes, 0 nays). Motion carried. Meeting adjourned at 6:40 p.m.
