REGULAR MEETING MINUTES

Chairman Golwitzer called the Regular meeting of the Bradley Fire & Police Commission to order on Tuesday, February 6, 2023, at 6:05 p.m.

REVIEW/APPROVAL OF MINUTES:

A motion was made by Chairman Golwitzer and seconded by Commissioner Glidewell to approve the January 6, 2023, Regular meeting minutes; January 17, 2023, January 18, 2023, January 19, 2023, Executive Session meeting minutes; and the January 17, 2023, January 18, 2023, January 19, 2023, January 26, 2023 Special meeting minutes. Roll call (2 ayes, 0 nays). Motion carried.

NEW BUSINESS:

A motion was made by Chairman Golwitzer to go into Executive Session to discuss personnel per 5ILCS120/2c1. This motion was seconded by Commissioner Glidewell. Roll call (2 ayes, 0 nays). Motion carried. Executive session was entered at 6:14 p.m. During the executive session, the Commission reviewed the background investigations completed for six police officer candidates on the Police Officer Final Eligibility Register. The Executive session was exited at 6:55 p.m. after the reviews were completed.

A motion was made by Chairman Golwitzer to disqualify and remove candidate Christian Slinkard from the Police Officer Final Eligibility Register in accordance with Chapter II Section 3 subsection h) of the Rules and Regulation of the Board of Fire and Police Commissioners in the Village of Bradley, Illinois. The motion was seconded by Commissioner Glidewell. Roll Call (2 Ayes, 0 Nays). Motion carried.

A motion was made by Commissioner Glidewell to disqualify and remove candidate Adam Blaskey from the Police Officer Final Eligibility Register in accordance with Chapter II Section 3 subsections f) and h) of the Rules and Regulation of the Board of Fire and Police Commissioners in the Village of Bradley, Illinois. The motion was seconded by Chairman Golwitzer. Roll Call (2 Ayes, 0 Nays). Motion carried.

Chief Barber reported that he received authorization to hire two police officers. A motion was made by Chairman Golwitzer and seconded by Commissioner Glidewell to approve extending a Conditional Offer

of Employment to Nathan Hess the top two candidate on the Police Officer Final Eligibility Register. Roll call (2 ayes, 0 nays). Motion carried.

A motion was made by Commissioner Glidewell and seconded by Chairman Golwitzer to approve extending a Conditional Offer of Employment to Zeffrey Duffield the next candidate on the Police Officer Final Eligibility Register. Roll call (2 ayes, 0 nays). Motion carried.

Chairman Golwitzer contacted Nathan Hess and Zeffrey Duffield during the meeting and extended a conditional offer of employment to both candidates contingent on successfully passing a background investigation, polygraph examination, pre-employment psychological examination and a medical examination. Both Hess and Duffield accepted the conditional offer of employment.

With no other business to discuss, a motion was made by Chairman Golwitzer and seconded by Commissioner Glidewell to adjourn the meeting. Roll call (2 Ayes, 0 Nays). Motion carried. Meeting adjourned at 7:38 p.m.
