1. O-3-16-1 an Ordinance adopting an Anti-Nepotism Policy within the Village of Bradley 1st reading

Trustee Watson had some concerns with the language in the Ordinance, specifically the definition of committed relationship and the relative clause. It was noted this is on 1st reading so adjustments can be made.

INSURANCE & FINANCE

Trustee Cyr stated the Committee met before the Board meeting and voted 3-0 to approve the Annual Audit FY 2015.

A motion was made by Trustee Cyr and seconded by Trustee Redmond to approve the Annual Audit FY 2015. (6 ayes 0 nays) Motion carried

Trustee Gadbois thanked Treasurer Pries for the exceptional and informative Audit review that the Board received and requested the Auditors be thanked for an exceptional job in their audit performance.

Insurance Renewals for 2016

Trustee Cyr stated that the Committee met earlier in the evening and voted 3-0 to approve the Insurance renewals for 2016.

A motion was made by Trustee Cyr and seconded by Trustee Carrico to approve the 2016 Insurance renewals (6 ayes 0 nays) Motion carried

UNFINISHED BUSINESS

Finance Committee received a letter from Bradley Bourbonnais Little League they need to make some Electrical improvements to Slater Field. The total cost for the repairs would be \$24,000 which will be split 3 ways between the Little League, Village of Bradley and the Village of Bourbonnais. The Committee voted 3-0 to approved a one time payout of \$8,000.00 from the Park fund to the BBLL for the improvements.

A motion was made by Trustee Balthazor and seconded by Trustee Redmond to approve the payout for the improvements at Slater Field. (5 ayes 0 nays 1 abstain Trustee Cyr) Motion carried

NEW BUSINESS

R-3-16-1 a Resolution to adopt the annual 1,000 hour standard IMRF Participation.

A motion was made by Trustee Gadbois and seconded by Trustee Balthazor to approve R-3-16-1 (6 ayes 0 nays) Motion carried

A recommendation from the Chair was to take the low bid from Gallagher Asphalt bid. A motion was made by Trustee Balthazor and seconded by Trustee Cyr to approve Gallagher Asphalt for the MFT project. (6 ayes 0 nays) Motion carried Republic Service Extension Proposal this was discussed at the Finance Committee this was voted 3-0 to return this to the Utilities Committee.

The Administrator and staff were looking for ways to update our Payroll System and they have decided to go with Paycom. The Finance Committee concurred with the decision on a 3-0 vote.

A motion was made by Trustee Cyr and seconded by Trustee Gadbois to approve Paycom for our new payroll system. (6 ayes 0 nays) Motion carried

A motion was made by Trustee Balthazor and seconded by Trustee Cyr to adjourn the meeting. The meeting was adjourned at 7:34 p.m. on a unanimous aye vote.
