Chairman Golwitzer called the Regular meeting of the Bradley Fire and Police Commission to order on Monday, March 4, 2024, at 6:00 p.m.

IN ATTENDANCE:

Chairman Golwitzer, Commissioner Glidewell and Fire Chief Kaderabek. Secretary Arrington was absent.

PUBLIC COMMENT: None

REVIEW/APPROVAL OF MINUTES:

A motion was made by Commissioner Glidewell and seconded by Chairman Golwitzer to approve the February 5, 2024, regular meeting minutes, the February 15, 2024, special meeting minutes and the February 5, 2024 executive session minutes. Roll call (2 ayes, 0 nays). Motion carried.

CORRESPONDENCE/COMMUNICATION: None

APPROVAL OF BILLS:

A motion was made by Chairman Golwitzer and seconded by Commissioner Glidewell to approve the \$3,800 invoice from Stanard & Associates for Police Sergeant promotional testing process 1 of 2 (#57173). Roll call (2 ayes, 0 nays). Motion carried.

UNFINISHED BUSINESS:

Reviewed and discussed the timeline for the Fire Lieutenant promotional process. Candidate orientation via Zoom is scheduled for March 7, 2024 at 9 a.m. The written exam is scheduled for April 17, 2024 at 9 a.m. and the Assessment Center exercises are scheduled for April 24, 2024 and April 25, 2024 as needed. Chief Kaderabek will distribute a sign-up sheet to all of the firefighters.

NEW BUSINESS:

Reviewed and discussed the timeline for the Police Sergeant promotional process. Seven police officers have signed up for the exam and study guides have been distributed. The written exam is scheduled for June 4, 2024 at 8 a.m. and the oral interviews are scheduled for June 15, 2024 at 9 a.m.

The commission reviewed the final draft of the revised Rules and Regulations of the Board of Police and Fire Commissioner's Village Of Bradley. The proposed revision adds police officer lateral hiring requirements and voice stress analysis (as an alternative for polygraph tests). A motion was made by Chairman Golwitzer and seconded by Commissioner Glidewell to adopt and approve the revisions as written. Roll call (2 ayes, 0 nays). Motion carried. Chairman Golwitzer will ensure a Notice of Publication is published in the Kankakee Daily Journal newspaper. The revised Rules and Regulations shall take effect ten (10) days subsequent to the publication pursuant to 65 ILCS 5/10-2.1-5.

Police officer lateral applications were launched on the ApplytoServe.com website on February 20, 2024. One applicant has applied as of February 29, 2024. The application deadline is March 22, 2024.

With no other business to discuss, a motion was made by Commissioner Glidewell and seconded by Chairman Golwitzer to adjourn the meeting. Roll call (2 ayes, 0 nays). Motion carried. Meeting adjourned at 6:13 p.m.
