**CALL TO ORDER**

The regular meeting of the Bradley Village Board was called to order on Monday, April 22, 2019 at 6:30 p.m. at the Bradley Municipal Hall. President Adams presided. Roll call: Trustee's Balthazor, Redmond, Gadbois, Watson, Barber and Allen, all were present.

A motion was made to remove 7C and to move up 17 G and 17 H after Presentation of minutes by Trustee Watson and seconded by Trustee Redmond (3 ayes 4 nays) Mayor voted Trustee Gadbois added 17 E Remarks of outgoing Trustee's move to 17 F Trustee Watson asked if there was an Executive Session – there is not.

O-4-19-7 an Ordinance Abating the Tax heretofore, levied for the tax year 2018 to pay the principal and interest on \$4,750,000 General Obligation Sewerage refunding bonds (Alternate Revenue Source), Series 2015A, of the Village of Bradley, Kankakee County, Illinois (1<sup>st</sup> reading)

A motion was made to waive the 2<sup>nd</sup> reading of O-4-19-7 by Trustee Gadbois and seconded by Trustee Redmond. (7 ayes 0 nays) Mayor voted, Motion carried

Trustee Watson wanted to read into the record that the newly Elected Trustee should have been Sworn in at the beginning of the Board meeting following the approval of the minutes.

Mayor stated he has a memo from the Village Attorney that statue is silent on whether the term beginning or end of the meeting. We are going with Tradition we have always done it at the end of the meeting. We have moved the swearing in up one meeting because of the 2007 ruling.

A motion was made to adopt R-4-19-3 by Trustee Gadbois and seconded by Trustee Allen (4 ayes 3 nays) Mayor voted, Motion carried

Trustee Watson noted regarding the newly Elected Trustee. Mayor stated it was duly noted.

Trustee Gadbois made a motion to reconsider the IGA R-4-19-3 and seconded by Trustee Allen (2 ayes 4 nays) Motion failed.

R-4-19-4 a Resolution authorizing an Intergovernmental Agreement between the Village of Bradley, Kankakee County, Illinois; The Village of Bourbonnais, Kankakee County, Illinois; and the Township of Bourbonnais, Kankakee county, Illinois, for the purpose of joint ownership and Operation of 2001 Volvo L50D End Loader.

A motion was made to adopt R-4-19-4 by Trustee Balthazor and seconded by Trustee Gadbois. (5 ayes 1 nay) Motion carried

R-4-19-6 a Resolution Approving a Hotel Tax Revenue Rebate Agreement by and between the Village of Bradley and the Kankakee County Convention and Visitors Bureau.

A motion was made to accept the re-appointment by Trustee Gadbois and seconded by Trustee Redmond. (6 ayes 0 nays) Motion carried

Trustee’s Balthazor thanked the Administration, all employees of the Village and welcomed in the new Board, he thanked his wife and his seatmate Lori Gadbois.

Trustee Allen thanked the staff that are here day in and day out that get the work done and protect us and keep things going. He welcomed in the new Board and wished them all the best.
