#### **UNFINISHED BUSINESS:**

- Firefighter Candidate testing procedures were discussed. Chairman Golwitzer obtained a quote from Stanard & Associates to conduct the testing. After discussion, Commissioner Hernandez made a motion to accept the quote from Stanard and Associates and to begin the testing process. This motion was seconded by Chairman Golwitzer.
