# ORDINANCE & TECHNOLOGY/BUILDING CODE

Trustee Redmond stated there was nothing under Code or IT.

O-4-19-1 an Ordinance granting a Special Use Permit for a planned development of certain property within the Village of Bradley, Kankakee County, Illinois (1260 Christine Drive) (1<sup>st</sup> reading)

Trustee Watson had questions about the terms of the agreement, which is 5 years and about the marketability.

A motion was made to waive the two readings by Trustee Redmond and seconded by Trustee Gadbois of O-4-19-1. (6 ayes 1 nay-Trustee Watson) Mayor voted.

A motion was made to approve O-4-19-1 by Trustee Gadbois and seconded by Trustee Allen (6 ayes 0 nays) Motion carried.

# LICENSE, ZONING, PLANNING & GRANTS

#### **UNFINISHED BUSINESS**

GWDC – gave a presentation on the marketability of Northfield Square Mall. Their Development Team was present. Michael Edgar – President, Caryn Kahn – Director of Communications, Shai Lothan – CEO. They started with the impact of CSL and Nucor.

# Summary:

Success will require both tourism bureau and local economic development efforts as large corporations expand along with the supply chain businesses the area should hope to attract. GWDC recommends that the Village of Bradley and the KCCVB work out a plan to accomplish The increase of 100,000 room nights stays needs to be accomplished as a part of this plan. A part of this plan should be budget and funding sources to keep the KCCVB a successful and integral part of the county's promotion.

# Recommendations:

Since there is no precedent anywhere in the State of Illinois to give control of their tax revenue to a Convention and Visitors Bureau such as the arrangement with the KCCVB:

It is their recommendation for the Village of Bradley to institute their own 5% occupancy hotel tax. The Village of Bradley to adopt a resolution indicating their desire to create the Bradley Convention Center District. The Village of Bradley enters into a MOU with KCCVB to develop a marketing strategy for the Bradley Convention Center District.

A motion was made by Trustee Allen and seconded by Trustee Redmond to approve the Kankakee Glass & Auto bid of \$39,980.00. (6 ayes 0 nays) Motion carried

R-4-19-1 a Resolution approving a Lease Agreement with the Kankakee Federation of Labor AFL-CIO.

Trustee Watson objected for the vote to be taken because some of the members had a conflict of accepting donations from the Federation of Labor

A motion was made to table R-4-19-1 by Trustee Gadbois and seconded by Trustee Balthazor (5 ayes 1 nay-Trustee Barber) This failed as 3/4 is needed to pass.

R-4-19-2 a Resolution authorizing an amendment of the Lease Agreement between the Village of Bradley and the Bradley-Bourbonnais Senior Citizens Club.

A motion was made to approve R-4-19-2 by Trustee Redmond and seconded by Trustee Balthazor. (5 ayes 2 nays) Mayor voted this failed, as 3/4 is needed to pass.

R-4-19-3 a Resolution approving Third Extension to an Intergovernmental Agreement between the County of Kankakee, City of Kankakee, City of Momence, Village of Bourbonnais, Village of Bradley and the Village of Manteno for the Promotion of Tourism.

This was suggested earlier in the meeting to be tabled by Trustee Redmond.

A motion was made by Trustee Redmond and seconded by Trustee Watson to table R-4-19-3 until Thursday, April 11, 2019 Insurance and Finance Committee meeting.

(5 ayes 2 nays-Trustee's Allen & Gadbois) Mayor voted , Motion carried
