A motion was made by Trustee Gadbois and seconded by Trustee Carrico to approve the agenda with the changes. (6 ayes 0 nays) Motion carried.

A motion was made by Trustee Cyr and seconded by Trustee Redmond to pay all bills and accounts for June 13, 2016 by recommendation of the Finance Committee. (5 ayes 0 nays 1 present) Motion carried

REPORT OF SPECIAL COMMITTEES

Chairman Smith was absent. Mayor Adams read his report he noted that on June 7, 2016 the Commission met they had one item on the Agenda. It was a request from Bradley Commons LLC (c/o DeBartolo Holding LLC) for special use permit to a service station consisting of 8-pump fuel station and food convenience store within a B-3 Commercial zoning district property commonly known as 2094 N. State Route 50, Bourbonnais, Illinois 60914 (PIN 17-09-09-106-008)

All Trustees were given a copy of the Planning Commission meeting minutes from June 7, 2016. (7-0) vote Section 60-300 (2) Q through D of our Village of Bradley Ordinance handbook.

REPORT OF STANDING COMMITTEES

ORDINANCE & TECHNOLOGY

1. O-5-16-1 an Ordinance Repealing Ordinance No. O-7-09-4 and Reinstating the Position of Deputy Chief in the Village of Bradley in Accordance with Ordinance No. O-6-03-2.

A motion was made to approve O-5-16-1 by Trustee Gadbois and seconded by Trustee Carrico. (6 ayes 0 nays) Motion carried

Trustee Watson wanted to know the salary range, it was stated that would be determined by the Chief of Police. He wanted to know what benefits there was to adding a Deputy Chief to the Village. Chief Johnston stated there are multiple and ongoing Clerical and Administrative duties that the Chief can't get to that the Deputy Chief would be handling. There would only be one Lieutenant replacement then the order of Command would be Chief, Deputy Chief and Lieutenant.

2. O-5-16-2 an Ordinance authorizing the purchase of Real Property located at 353 W. Broadway, Bradley, Illinois having permanent index No. 17-09-29-125-015 purchase price \$8,500.00

A motion was made to approve O-5-16-2 by Trustee Gadbois and seconded by Trustee Cyr (6 ayes 0 nays) Motion carried

The Attorney wanted to make it known Trustee Watson has a conflict of interest and he should not have voted on this matter.

3. O-6-16-1 an Ordinance granting a Special Use Permit for the property located at 2094 N. State Route 50 in Bradley, Illinois

A motion was made to waive the two readings by Trustee Redmond and seconded by Trustee Balthazor. (7 ayes 0 nays) Mayor voted. Motion carried

A motion was made to adopt O-6-16-1 by Trustee Gadbois and seconded by Trustee Cyr (6 ayes 0 nays) Motion carried

Trustee Gadbois wanted to know about gaming machines. Mr. Rushing was at the meeting and said they had no intention of putting any gaming machines in.

UNFINISHED BUSINESS

There was no unfinished business

NEW BUSINESS

R-6-16-1 a Resolution authorizing the sale of surplus vacant Real Estate: a water retention area located along the 1300 block of North Kinzie Avenue having Permanent Index No 17-09-16-301-016.

The Attorney stated that if this Resolution is approved it would be published for bids and there would be a bid opening and we would have to receive at least 80% of the appraised value. Trustee Watson had questions on the appraisal and on the upkeep which would be underneath the property. Engineer Gingerich stated that the drainage Ordinance of the Village of Bradley would be in place and must be followed.

A motion was made to approve R-6-16-1 by Trustee Balthazor and seconded by Trustee Gadbois (6 ayes 0 nays) Motion

R-6-16-2 a Resolution on behalf of the Village of Bradley in support of submission of the Schuyler Avenue and Broadway Street bike lane striping project, the Illinois Route 50 shared path project from the Northfield Square Mall entrance to Larry Power Road, and the Illinois Route 50 shared path project from Armour Road to Mulligan Drive Phases 1 & 2 to the Illinois Department of Transportation for consideration under the Illinois Transportation Enhancement Program.

A motion was made to approve R-6-16-2 by Trustee Carrico and seconded by Trustee Balthazor (6 ayes 0 nays) Motion carried

The Mayor stated that KANCOMM is upgrading their consoles the cost to the Village would be 147,410.84l. Bradley would like a 5 year pay off, KANCOMM countered that offer with a 2 year pay off. There was a tentative agreement of 2 years 1 year in arrears, with the stipulation that strong consideration of one of the consoles be here at the Bradley Dispatch Center.

A motion was made to approve the agreement with KANCOMM by Trustee Gadbois and seconded by Trustee Cyr (6 ayes 0 nays) Motion carried

Side and corner yard pool variance - it is noted that residents are having a hardship because they have no back yard to put a pool in and they need to use the side yard. The Attorney suggested we amend our Zoning code so that people who want to have a side yard pool can come before the Planning and Zoning Commission and ask for a variance, the commission could then look at each request individually.

Village of Bradley 125 year celebration will be next year Trustee Watson wanted to know if there are any plans for this celebration. Mayor Adams stated there are some plans for late summer of 2017 he has asked someone to come forward as a Chairman they have not come forward yet. They will let him know by August so plans can go forward.

ADJOURNMENT

A motion was made by Trustee Balthazor and seconded by Trustee Redmond to adjourn the meeting. The meeting was adjourned at 7:30 p.m. on a unanimous aye vote.
