## CORRESPONDENCE/COMMUNICATION:

### APPROVAL OF BILLS:

A motion was made by Chairman Golwitzer and seconded by Secretary Arrington to approve an invoice from Physicians Immediate Care for pre-employment physicals for \$1385.00. Roll call (3 ayes, 0 nays). Motion carried.

#### UNFINISHED BUSINESS:

The revisions being made to the Village of Bradley Fire and Police Rules and Regulations were not ready for review. This action was tabled to a future meeting.

Chairman Golwitzer reported that eight individuals have applied for the full-time firefighter position. The deadline to submit applications is June 10, 2022.

Chief Kaderabek reported that he will be meeting with Stanard on Wednesday, Jun 8, 2020 to discuss and work on the Firefighter Lieutenant promotional process actions.

The commission reviewed the medical report for firefighter candidate Brian Souligne. The commissioners expressed no concerns with the results.
