REGULAR MEETING MINUTES

Chairman Golwitzer called the Regular meeting of the Bradley Fire & Police Commission to order on Monday, July 6, 2021 at 6:00 p.m.

IN ATTENDANCE:

Chairman Golwitzer and Secretary Arrington. Commissioner Glidewell arrived 15 minutes after the meeting started.

REVIEW/APPROVAL OF MINUTES:

A motion was made by Secretary Arrington and seconded by Chairman Golwitzer to approve the June 7, 2021 Regular meeting minutes. Roll call (2 ayes, 0 nays, 1 absent). Motion carried.

UNFINISHED BUSINESS:

The Police Sergeant promotional testing preparation was discussed. The Police Sergeant written test is scheduled for July 28, 2021 at 0900 hours. The Oral interviews are scheduled for August 12 and 13, 2021. The location for the written test and oral boards will be on the second floor of the Village of Bradley Fire Department building.

NEW BUSINESS:

Additional interviews for the top 14 candidates on the Police Officer Initial Eligibility Register will be scheduled for Tuesday, July 13, 2021, Thursday, July 15, 2021, and Monday, July 19, 2021. Secretary Arrington volunteered to contact the candidates to schedule their interviews. The candidates being interviewed all have points of 95 or greater on the eligibility register.

The Commissioners reviewed the preference point claims received from the Firefighter candidates on the Firefighter Initial Eligibility Register. The documents were reviewed and preference points were applied to each candidate as prescribed by the Rules and Regulations of the Board of Fire and Police Commissioners for the Village of Bradley. The Initial Eligibility Register was updated with the preference points awarded and a motion was made by Commissioner Glidewell to approve the updated list as the Firefighter Final Eligibility Register. This motion was seconded by Secretary Arrington. Roll Call (3 Ayes, 0 Nays). Motion Carried.

Chairman Golwitzer reported that the Commission received authorization to hire two firefighters. A motion was made by Commissioner Glidewell and seconded by Secretary Arrington to approve extending Conditional Offers of Employment to the top two candidates on the Firefighter Final Eligibility Register (Aaron Anderson and Hayden Peters). Roll call (3 ayes, 0 nays). Motion carried.

Aaron Anderson and Hayden Peters were contacted during the meeting and extended a Conditional Offer of Employment contingent on successfully passing a background investigation, polygraph examination, pre-employment psychological examination and a medical examination. Hayden Peters Conditional Offer of Employment also included being certified by the State of Illinois as Basic Operations Firefighter. Both candidates accepted the Conditional Offers of Employment.

With no further business to discuss, a motion was made by Commissioner Glidewell and seconded by Chairman Golwitzer to adjourn the meeting. Roll call (3 ayes, 0 nays). Motion carried. Meeting adjourned at 7:01 p.m.
