Chairman Golwitzer called the Regular meeting of the Bradley Fire & Police Commission to order on Monday, August 2, 2021, at 6:00 p.m.

Chairman Golwitzer, Secretary Arrington, Commissioner Glidewell and Police Chief Barber.

REVIEW/APPROVAL OF MINUTES:

A motion was made by Commissioner Glidewell and seconded by Secretary Arrington to approve the July 6, 2021 Regular meeting minutes, the July 13, 2021, July 15, 2021 and July 19, 2021 Special meeting minutes and the July 13, 2021, July 15, 2021 and July 19, 2021 Executive session meeting minutes. Roll call (3 ayes, 0 nays). Motion carried.

NEW BUSINESS:

The updated Police Officer Final Eligibility Register was reviewed. A motion was made by Secretary Arrington and seconded by Commissioner Glidewell to approve the updated Final Eligibility Register. Roll call (3 ayes, 0 nays). Motion carried.

The updated Police Officer Initial Eligibility Register was reviewed. A motion was made by Secretary Arrington and seconded by Commissioner Glidewell to approve the updated Initial Eligibility Register. Roll call (3 ayes, 0 nays). Motion carried.

Chief Barber reported that he received authorization to hire a police officer. A motion was made by Chairman Golwitzer and seconded by Commissioner Glidewell to approve extending a Conditional Offer of Employment to the top candidate on the Police Officer Final Eligibility Register. Roll call (3 ayes, 0 nays). Motion carried.

Chairman Golwitzer contacted the top candidate, Matthew Monferdini, during the meeting and extended a Conditional Offer of Employment contingent on successfully passing a background investigation, polygraph examination, pre-employment psychological examination and a medical examination. Monferdini accepted the Conditional Offer of Employment.

The Commissioners discussed whether the board should perform oral interviews with additional candidates on the Police Officer Initial Eligibility Register. It was decided that no additional interviews are needed at this time.

A motion was made by Chairman Golwitzer to go into Executive Session to discuss personnel per 5ILCS120/2c1. This motion was seconded by Commissioner Glidewell. Roll call (3 ayes, 0 nays). Motion carried. Executive session was entered at 6:14 p.m.

The meeting was returned to Regular session at 7:12 p.m. During the Executive session, the Commissioners reviewed the Police Sergeant Promotional Exam results, the Department Merit and Efficiency Ratings for the police officers taking the exam and the Conditional Offer status of firefighter candidates.

After the Executive session, it was determined that a follow-up action was required for the Police Sergeant Promotional process. Chairman Golwitzer will send e-mails to the officers that took the Police Sergeant Written Promotional Exam informing them of their results. No follow-up actions were required for the Firefighter Candidate Conditional Offers of Employment.

With no further business to discuss, a motion was made by Chairman Golwitzer and seconded by Commissioner Glidewell to adjourn the meeting. Roll call (3 ayes, 0 nays). Motion carried. Meeting adjourned at 7:19 p.m.
