Roll call: Trustee's Redmond, LeBran, Westphal, Billingsley, and Watson were all present.

He also spoke about property at 170 West Broadway; they wanted to add a 6ft fence to hide vehicles from view. Trustee Redmond made a motion to approve the minutes and was seconded by Trustee Tieri (6 ayes 0 nays) Motion carried

- 3. Terry Memenga spoke about demolition bids for the property at 359 W Broadway. Lowest bid was from Patrick Ryan Construction for \$14,000.
