Aqua filed for this increase in May 2017, if approved this would not go into effect until April 2018. Based on the average usage billed of 4,500 gallons per day, the increase would be approximately \$8.00 per monthly bill or .27 a day.

Sewer Rate increase for Village residents, it was noted that a few months ago there was to be a Committee of the Whole meeting regarding the increase. Mayor will set a date for the Committee of the Whole.
