

BRADLEY FIRE & POLICE COMMISSION
REGULAR MEETING MINUTES

COMMISSIONERS

Chairman Golwitzer called the Regular meeting of the Bradley Fire & Police Commission to order on Monday, August 7, 2023, at 6:00 p.m.

IN ATTENDANCE:

Chairman Golwitzer, Secretary Arrington, Commissioner Glidewell, Fire Chief Kaderabek and Police Chief Barber.

PUBLIC COMMENT: None

REVIEW/APPROVAL OF MINUTES:

A motion was made by Commissioner Glidewell and seconded by Secretary Arrington to approve the July 3, 2023, regular meeting minutes and the July 27, 2023 special meeting minutes. Roll call (3 ayes, 0 nays). Motion carried.

CORRESPONDENCE/COMMUNICATION:

Police Officer candidate Isiah Jackson submitted his signed letter of acceptance for the conditional offer of employment as a full-time police officer.

APPROVAL OF BILLS:

A motion was made by Chairman Golwitzer and seconded by Commissioner Glidewell to approve the \$1,500 invoice from Stanard and Associates for the firefighter application process (#55169). Roll call (3 ayes, 0 nays). Motion carried.

UNFINISHED BUSINESS:

Commissioner Glidewell signed the Certificate of Appointment for Lucas Schejbal.

NEW BUSINESS:

A motion was made by Chairman Golwitzer to enter into Executive session per 5ILCS120/2c1. The motion was seconded by Commissioner Glidewell. Roll call (3 ayes, 0 nays). Motion carried. Executive session was entered at 6:09 p.m. During the executive session, the commission reviewed the psychological evaluation, polygraph results and the employment application for police officer candidate Isiah Jackson who was given a conditional offer of employment for a full-time police officer position. The executive session was exited at 6:41 p.m. after the review was completed.

A motion was made by Chairman Golwitzer to revoke the conditional offer of employment made to police officer candidate Isaiah Jackson in accordance with Chapter II Section 3 subsection f) and h) of the Rules and Regulation of the Board of Fire and Police Commissioners in the Village of Bradley, Illinois. The motion was seconded by Commissioner Glidewell. Roll call (3 ayes, 0 nays). Motion carried.

A motion was made by Chairman Golwitzer and seconded by Commissioner Glidewell to approve extending a conditional offer of employment to the top police officer candidate on the Police Officer Final Eligibility Register. Roll call (3 ayes, 0 nays). Motion carried.

The top police officer candidate, Rolando Iglesias, was contacted and extended the conditional offer of employment contingent on successfully passing a background investigation, polygraph test, psychological examination, medical examination and power test. Iglesias accepted the conditional offer of employment as a full-time police officer.

The commissioners reviewed the proposal from Stanard and Associates for police officer applications and written exams. A motion was made by Commissioner Glidewell and seconded by Secretary Arrington to approve the proposal with no fees for the applicants. Roll call (3 ayes, 0 nays). Motion carried. Chairman Golwitzer will sign and return the proposal to Stanard and Associates. It was agreed that the application deadline date would be September 15, 2023.

The Commissioners reviewed the firefighter written exam results. 10 candidates applied and took the exam. All ten candidates passed the exam.

The candidate's names were sorted in order of their written exam scores and the Firefighter Preliminary Eligibility Register was drafted. A motion was made by Commissioner Glidewell to approve the Firefighter Preliminary Eligibility Register and the motion was seconded by Secretary Arrington. Roll call (3 ayes, 0 nays). Motion carried.

Oral interviews will be conducted for all ten candidates. The interviews will be scheduled with the candidates by Secretary Arrington to be completed on August 16, 2023 and August 17, 2023.

With no other business to discuss, a motion was made by Commissioner Glidewell and seconded by Commissioner Arrington to adjourn the meeting. Roll call (3 ayes, 0 nays). Motion carried. Meeting adjourned at 7:26 p.m.
