O-8-18-5 an Ordinance Amending Ordinance No. O-8-17-3, passed by the Corporate Authorities of the Village of Bradley on August 21, 2017. (1st reading)

NEW BUSINESS

R-9-18-3 a Resolution authorizing an extension of the Intergovernmental Agreement for the promotion of tourism between the Village of Bradley, the County of Kankakee, the City of Kankakee, the City of Momence, the Village of Bourbonnais, and the Village of Manteno.

A motion was made to adopt R-9-18-3 was made by Trustee Allen and seconded by Trustee Gadbois.

(4 ayes, Trustee's Balthazor, Gadbois, Allen & Mayor Adams 3 nays Trustee's Redmond, Watson & Barber) Motion carried

Trustee Watson had several questions with regards to the extension and why it was needed. It was noted that the County are awaiting an opinion from the Attorney General with regards to IMRF being allowed for the employees of the Kankakee County Convention Visitor's Bureau. A six-month extension is needed to wait for that opinion. We do not want that to interfere with a \$134,000 State Grant that the Visitor's Bureau gets from the State. Trustee Watson had questions with regards to exactly what does the Visitor's Bureau do? Staci Wilken from the KCCVB was present and passed out a report of the FY 2017-2018 Year in Review, which covered Marketing, Sales, Finance, CTAP, Economic Development, Grass roots efforts, the KCCVB Team and the Organization. Trustee Watson had a question how much revenue raises with the 5% tax on the hotels, it was noted that the tax raises about \$685,000 and about \$400,000 comes from Bradley hotels. Trustee Watson thought there should be another meeting to discuss and he wanted to formulate some questions for the KCCVB.

R-9-18-4 a Resolution authorizing various agreements in lieu of Re-annexation (1050 Liberty Street) The Attorney read into the record that there are three agreements within the resolution. The Attorney noted this would be taken as a first reading that we would proceed forward on the vote of R-9-18-4 as a second reading at the next Board meeting.

Trustee Watson had questions about Republic billing problems. He noted that he would be looking into the contract and asking questions at a future meeting.

A motion was made by Trustee Allen and seconded by Trustee Barber to go into Executive Session at 7:00 p.m. 5ILCS 120/2 (c) (3) (6) (6 ayes 0 nays) Motion carried

Back in session at 8:30 p.m. Roll call all Trustees were present.
