APPROVAL OF BILLS:

A motion was made by Chairman Golwitzer and seconded by Secretary Arrington to approve the \$650 invoice from C.O.P.S. and F.I.R.E. Personnel Testing for firefighter pre-employment polygraph and psychological tests (#108354). Roll call (3 ayes, 0 nays). Motion carried.

NEW BUSINESS:

Chairman Golwitzer reviewed the status of the police officer written application submittals. 10 candidates have applied for the position to date. The application deadline is 9/15/2023. The online written exam will be taken between 9/28/2023 and 9/30/2023.

A motion was made by Chairman Golwitzer to remove firefighter candidate Neal Haemker from the Firefighter Preliminary Eligibility Register in accordance with Chapter II Section 3 subsection a) of the Rules and Regulations of the Board of Fire and Police Commissioners in the Village of Bradley, Illinois. The motion was seconded by Commissioner Glidewell. Roll call (3 ayes, 0 nays). Motion carried.

The results of the Firefighter oral interviews were reviewed by the commissioners and a Firefighter Initial Eligibility Register was established. Commissioner Glidewell made a motion to approve the Firefighter Initial Eligibility Register and Chairman Golwitzer seconded the motion. Roll call (3 ayes, 0 nays). Motion carried.

Chairman Golwitzer will send e-mails tonight after the meeting to all candidates on the Firefighter Initial Eligibility Register detailing the process for Firefighter preference claims which will be due in 10 days.

Once the preference point claims are received, the Commissioners will establish a final Firefighter Eligibility Register.
