I hope all is well! The Village Board has amended the Liquor Ordinance in the last five years, Ordinance and updates can be found at Bradleyil.org.

All current Village of Bradley Liquor Licenses will expire on Friday, May 31, 2024. This is your renewal notice for the licensing year of June 1, 2024 - May 31, 2025.

New application forms must be completed each year. We have enclosed a copy for your convenience. <u>If the</u> <u>manager has changed since last year OR if it has been more than 5 years since fingerprints have been run</u>, have the local manager/owner complete the enclosed Authorization form and contact our office for a background investigation including fingerprints to be completed as required by Illinois State Police.

All of the following items must be submitted by - Monday. May 20, 2024

- o Completed application form with current, updated information.
- Application affidavit signed by two members and notarized.
- Certificate of Insurance showing General Liability & Dram Shop coverage <u>and</u> listing the Village of Bradley as an Additional Insured.
- Proof of ownership or copy of the lease agreement (if not already on file)
- Articles of Incorporation (if not already on file)
- Background Authorization and fingerprints as required (S52.00 payable to Village of Bradley)
- If the manager has changed since last year OR if it has been more than 5 years since fingerprints have been run.
- Payment for annual fee (Please see Chart for annual fee)
- Copy of a current State of Illinois Liquor License for our files

Licenses with gaming terminals – Gaming terminals are \$250 per machine. Gaming fees must be paid in full before we issue liquor license.

Please indicate where you would like a copy of the Liquor License to be emailed. Original certificates will be available for pick-up at Village Hall during business hours beginning May 31st.

Liquor Licenses for the new licensing year will not be issued until all the above items are received. Also, please keep the following State and/or Local laws in mind when renewing your liquor license:

- The Dram Shop should run concurrently with the license year.
- Residency Requirements as permitted by State Law for sole proprietorships.
