Dear Applicant:

Enclosed is a Liquor License application as you requested. Also enclosed is a Background Authorization form. Fingerprinting is also required by the Illinois State Police with a \$52.00 fee payable to the Village of Bradley.

The application, along with your Certificate of Insurance, Articles of Incorporation (if applicable), proof of ownership or lease (of premise described in the application) and fee should be submitted to our office at your earliest convenience. The Village of Bradley should be listed as an additional insured on Certificates of Insurance.

Licenses with gaming terminal- Gaming terminal fee is \$250 per machine. Gaming terminal fees must be paid in full before we issue liquor license.

Please keep the following State and/or Local laws in mind when submitting your application:

- 1. The Dram Shop should run concurrently with the license year (\$1,000,000 liability), June 1- May 31.
- 2. Residency requirements as permitted by State law (for Sole Proprietors).
- 3. Annual fee for a Liquor License (Please see fee chart for annual fee)
