ORDINANCE NO. 0-01-24-01

**AN ORDINANCE AMENDING CHAPTER 52 (TRAFFIC AND VEHICLES), ARTICLE II (VEHICLE EQUIPMENT, SIZE, WEIGHT, LOAD AND CONDITION), SECTION 52-45 (LOAD LIMITS ON CERTAIN STREETS) OF THE VILLAGE OF BRADLEY CODE OF ORDINANCES**

**WHEREAS**, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, pursuant to Section 11-40-1 of the Illinois Municipal Code (65 ILCS 5/11-40-1), the Village is authorized to regulate vehicles conveying loads within the Village; and

**WHEREAS**, pursuant to Section 11-80-2 of the Illinois Municipal Code (65 ILCS 5/11-80-2), the Village is authorized to regulate the use of Village streets; and

**WHEREAS**, pursuant to Section 11-208(a)(7) of the Illinois Vehicle Code (625 ILCS 5/11-208(a)(7)), the Village is authorized to restrict highway use within the Village as authorized pursuant to Chapter 15 of the Illinois Vehicle Code; and

**WHEREAS**, pursuant to Section 15-316 of the Illinois Vehicle Code (625 ILCS 5/15-316), the Village is authorized to prohibit the operation of, or impose weight limitations, on trucks or other commercial vehicles on highways under the Village's jurisdiction; and

**WHEREAS**, the Village previously exercised this authority by enacting Section 52-45 of the Village Code; and

**WHEREAS**, the Corporate Authorities have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to amend Section 52-45 of the Village Code as forth in this Ordinance.

**NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** That Chapter 52 (Traffic and Vehicles), Article II (Vehicle Equipment, Size, Weight, Load and Condition), Section 52-45 (Load Limits on Certain Streets) of the Village Code is hereby amended, as follows:

**Sec. 52-45. – Load limits on certain streets.**

It shall be unlawful for any person to drive any motor vehicle, truck, or trailer combination, truck tractor semitrailer combination or truck tractor semitrailer and trailer combination, weighing more than 14,000 pounds gross weight including the load thereon on any of the improved streets in the village except for the

following designated village truck routes limited to a maximum of 73,280 pounds gross weight, unless a special permit is issued by the village clerk:

Bradford Drive, from Industrial Drive to west end (at Railroad).

Broadway Street (East), from Schuyler Avenue to Van Buren Street.

Broadway Street (West), from Schuyler Avenue to Kennedy Drive (US Route 45).

Brookmont Boulevard, from Kennedy Drive (US Route 45) to west end (Water Pollution Control Plant).

Christine Drive, from North Street to Armour Road.

Euclid Avenue, from Broadway Street to North Street.

Forest Avenue, from Superior Street to Goodwin Street.

Goodwin Street, from Michigan Avenue to Washington Avenue.

Grove Street, from Washington Avenue to West Avenue.

Industrial Drive, from North Street to north end.

Ken Hayes Drive

Ken Hayes Drive, Loop Road around Northfield Mall to include access roads from US Route 50 (Kinzie Avenue) and from Larry Power Road access road.

Kinneman Drive, from Armour Road to Tighe Drive.

Larry Power Road, from Kinzie Avenue (US Route 50) to East access road to Ken Hayes Drive.

Lawn Street, from Michigan Avenue to West Avenue.

Locke Drive, from Armour Road to north end.

McKnight Road

Michigan Avenue, from Goodwin Street to South Street.

Mulligan Drive, from Kinzie Avenue (US Route 50) to Christine Drive.

North Street, from Kennedy Drive (US Route 45) to Christine Drive.

Perry Street, from Michigan Avenue to West Avenue.

Progressive Way

Schuyler Avenue, from South Street to East Broadway Street.

South Street, from Michigan Avenue to Washington Avenue.

Superior Street, from Kennedy Drive (US Route 45) to Forest Avenue.

Tighe Drive, from Locke Drive to Kinneman Drive.

Washington Avenue, from North Street to Goodwin Street and from South Street to Brookmont Boulevard.

Water Tower Plaza Drive

(Code 1973, § 25-137; Code 1985, § 12-33; Ord. No. O-1-03-2, 2-10-2003)

**SECTION 3.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 4.** That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

**SECTION 5.** That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

**SECTION 6.** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.


