AN ORDINANCE AMENDING CHAPTER 12 (BUSINESS REGULATION), ARTICLE IX (HOTEL OPERATOR'S OCCUPATION TAX), SECTION 12-352 (TAX IMPOSED; EXEMPTION) OF THE BRADLEY VILLAGE CODE TO MODIFY THE ACCRUAL DATE FOR THE VILLAGE'S HOTEL TAX

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, pursuant to Section 8-3-14 of the Illinois Municipal Code (65 ILCS 5/8-3-14), the Corporate Authorities of the Village are authorized to impose a tax upon all persons engaged, within the Village, in the business of renting, leasing, or letting rooms in a hotel at a rate not to exceed five percent (5%) of the gross rental receipts from such renting leasing, or letting (the "Hotel Tax"); and

WHEREAS, the Corporate Authorities are further authorized to provide for the administration and enforcement of the Hotel Tax, as well as for the collection of said tax from those persons that are subject thereto; and

WHEREAS, the Corporate Authorities previously exercised this authority and adopted Ordinance Number O-5-19-4 on May 28, 2019, creating a Hotel Tax for the Village to begin to accrue on July 1, 2019; and

WHEREAS, the Village previously entered into an intergovernmental agreement with the County of Kankakee, City of Kankakee, City of Momence, Village of Bourbonnais, Village of Bradley, and the Village of Manteno for the promotion of tourism (the "IGA") which prohibited the Village, or any other municipal party thereto, from imposing a municipal hotel operators' occupation tax within its corporate boundary during the term of the IGA commencing upon April 30, 2019 through June 30, 2024; and

WHEREAS, the IGA sets to expire on June 30, 2024 and the Corporate Authorities desire for the Hotel Tax to begin to accrue on July 1, 2024; and

WHEREAS, the Corporate Authorities have determined that amending the Village Code to change the date the Hotel Tax begins to accrue, as set forth in this Ordinance, is in the best interests of the Village and its residents.

NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. Chapter 12 (Business Regulation), Article IX (Hotel Operator’s Occupation Tax), Section 12-352 (Tax Imposed; Exemption) is hereby amended in part, as follows:

Sec. 12-352 – TAX IMPOSED; EXEMPTION:

- A. There is hereby imposed a tax upon all persons engaged in the rental or leasing of any rooms in a hotel within the corporate boundaries of the Village at a rate of five percent (5%) of gross rental or leasing receipts, which tax shall begin to accrue on July 1, 2024, and shall thereafter be collected pursuant to this Article.

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 4. That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

SECTION 5. That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 6. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

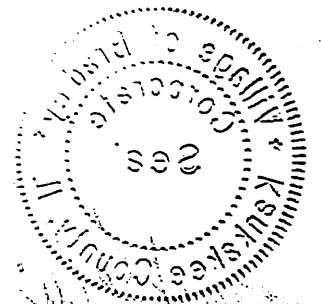


