**AN ORDINANCE AMENDING CHAPTER 20 (FIRE PREVENTION AND PROTECTION), ARTICLE II (FIRE DEPARTMENT), SECTION 20-40 (PART-TIME FIREFIGHTERS) OF THE BRADLEY VILLAGE CODE**

---

**WHEREAS**, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, pursuant to 65 ILCS 5/11-6-1, *et seq.*, the Village of Bradley is authorized to operate a fire department for the protection of the Village and its citizens; and

**WHEREAS**, the Corporate Authorities of the Village previously exercised the Village's authority to operate a fire department, *inter alia*, by enacting Chapter 20 (Fire Prevention and Protection), Article II (Fire Department) of the Village code; and

**WHEREAS**, the Corporate Authorities of the Village have determined that it is necessary, expedient to amend Chapter 20 (Fire Prevention and Protection), Article II (Fire Department), Section 20-40 (Part-time firefighters) of the Village code as set forth in this Ordinance.

**NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** Chapter 20 (Fire Prevention and Protection), Article II (Fire Department), Section 20-40 (Part-time firefighters) of the Village code is hereby amended in part to read as follows:

**Sec. 20-40. Part-time firefighters.**

There is hereby created a part-time position of employment with the Village of Bradley that shall be known as "part-time firefighter," as follows:

\* \* \*

(7) All part-time firefighters of the village shall serve a minimum probationary period of 12 months upon hire.

(8) Part-time firefighters shall be paid at an hourly rate for time actually worked, as follows:

	Firefighter/Paramedic	Firefighter/EMT-B	Paramedic (only)	EMT-B (only)
Pay Scale	\$22.00/hr	\$20.00/hr	\$21.00/hr	\$18.00/hr

(9) Part-time firefighters shall further be paid a weekend premium, in addition to their normal hourly rate, for time actually worked on Saturdays and Sundays, as follows:

Firefighter/Paramedic	Firefighter/EMT-B	Paramedic (only)	EMT-B (only)
\$3.00/hr	\$2.00/hr	\$2.00/hr	\$1.00/hr

**SECTION 3.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 4.** That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

**SECTION 5.** That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

**SECTION 6.** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.


