**ORDINANCE NO. O-1-16-4**

**AN ORDINANCE GRANTING A SPECIAL USE PERMIT  
FOR THE PROPERTY LOCATED AT  
350 N. KENNEDY DR., BRADLEY, IL**

**WHEREAS**, on January 5, 2016 and January 11, 2016, at meetings of the Village of Bradley Planning and Zoning Commission (hereinafter the "Plan Commission"), the Plan Commission held a public hearing on the application of the Petitioner, Khaleed Shaqildi d/b/a Franklin Motor Credit, Inc., (hereinafter the "Petitioner"), for a special use permit in a B-2 Commercial district to operate a used car sales lot at the property legally described as:

VILLAGE OF BRADLEY SH LT 6 & ALL LTS 7-8 BLK 10 29-31-12E

Commonly known as: 350 N. KENNEDY DR., BRADLEY, IL 60915

P.I.N.: 17-09-29-100-029

**WHEREAS**, notice of public hearing was published in the *Daily Journal* on December 16, 2015; and

**WHEREAS**, the Plan Commission has made its findings on the application and recommended that the special use permit be approved for the subject property by a majority vote, as reflected in the minutes of the public hearings of January 5, 2016 and January 11, 2016, incorporated herein by reference as though fully set forth; and

**WHEREAS**, the President & Board of Trustees of the Village have considered the Findings and Recommendation of the Plan Commission and all of the facts and circumstances affecting the Application, and the President and Board of Trustees have determined that it is appropriate to grant the special use permit as provided in this Ordinance; and

**WHEREAS**, the President and Board of Trustees have determined that the granting of the special use permit for the use set forth in Petitioner's application serves a public purpose and will be in the best interests of the Village of Bradley upon the conditions set forth in this Ordinance pursuant to Section 60-393 *et seq.* (Division 7 - Special Uses) of the Zoning Chapter of the Village's Code of Ordinances (hereinafter "Zoning Code").

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Bradley, Kankakee County, State of Illinois, as follows:

**Section 1. RECITALS.** The foregoing recitals are incorporated into this Ordinance as findings of the President and Board of Trustees.

**Section 2. SPECIAL USE PERMIT GRANTED.** The application of the Petitioner for a special use permit in a B-2 Commercial district to operate a used car sales lot is granted for the Subject Property, subject to the conditions set forth in §§3, 4 and 5 of this Ordinance.

**Section 3. REPORTS, EXHIBITS & TESTIMONY.** The special use permit granted by this Ordinance is in strict compliance with the application on file with the Village and with the reports, exhibits, and testimony presented to the Plan Commission.

**Section 4. CONDITIONS OF SPECIAL USE PERMIT.** The special use permit granted herein is subject to the following conditions in the interest of the public health, safety and welfare as prescribed by Chapter 60, Article VIII, Division 7, *et seq.*, of the Village's Zoning Code:

1. Compliance with M-Industrial District. The special use granted herein shall comply with all other applicable requirements of the B-2 Commercial District.
2. Special Use Shall Run With The Parcel. The special use shall be transferable to a new owner or subsequent lessee provided that the use approved by this Ordinance does not change. Any change to the use by the current owner or any subsequent owner and/or lessee shall require reapplication, hearing and approval in the manner provided by the Village's Zoning Ordinance.
3. Compliance with Codes, Ordinances, and Regulations.
  - a. The provisions of the Village Code of Bradley and the Village's Zoning Ordinance apply to and govern the Subject Property. All activities at the Subject Property shall comply with all Village codes, ordinances, and regulations at all times.
  - b. All open off-street vehicular parking areas and driveways shall be improved with all-weather dustless material consisting of the following:
    - i. 8" thick compacted aggregate base with a 3" thick hot mix asphalt surface; or
    - ii. 4" thick compacted aggregate leveling base with a 5" thick air-entrained appropriate portland cement concrete mix wearing surface
4. Inspection. The Petitioner shall allow Village inspectors to inspect all portions of the building located at the Subject Property upon request by the Village at a mutually convenient time.
5. Execution of Ordinance. This Ordinance shall be signed by the Petitioner to signify his agreement to the terms hereof.

**Section 5. VIOLATION OF CONDITION OR CODE.** Any violation of (i) any term or condition set forth in this Ordinance or (ii) any applicable code, ordinance, or regulation of the

Village shall be grounds for the immediate rescission by the Board of Trustees of the approvals granted pursuant to this Ordinance.

**Section 6. SEVERABILITY AND REPEAL OF INCONSISTENT ORDINANCES.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**Section 7. EFFECTIVE DATE.** The Clerk of the Village of Bradley shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form and this Ordinance shall take effect upon its approval and publication in pamphlet form as so certified.
