**AN ORDINANCE AUTHORIZING THE SALE OF PERSONAL PROPERTY OWNED BY  
THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, STATE OF ILLINOIS**

**WHEREAS**, the Board of Trustees of the Village of Bradley, Kankakee County, Illinois, has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, pursuant to 65 ILCS 5/11-76-4, the corporate authorities of the Village of Bradley may authorize the sale of personal property when it is no longer necessary or useful, or in the best interests of the Village, to retain said personal property; and

**WHEREAS**, the Village owns an ambulance that is a 2005 Ford Cutaway, E450 SUP, with Vehicle Identification Number 1FDXE45P05HB24285 (“ambulance”); and

**WHEREAS**, the ambulance has required repair and refurbishing, including the replacement of its chassis; and

**WHEREAS**, in the opinion of a majority of the corporate authorities of the Village of Bradley, it is no longer necessary, useful, or in the best interest of the Village to retain ownership of the old chassis which is being replaced, and the Village would be best served by its sale.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BY THE BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS PURSUANT TO ITS STATUTORY AUTHORITY AS FOLLOWS:**

**SECTION 1.** The President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct and complete and are hereby incorporated by reference thereto and made a part hereof.

**SECTION 2.** The Village Clerk of the Village of Bradley and/or the Chief of the Bradley Fire Department are hereby authorized and directed to sell the used vehicle chassis for the subject ambulance to Fire Service, Inc. of St. John, Indiana, in the amount of THREE HUNDRED DOLLARS (\$300.00).

**SECTION 3.** In the event that any provision or provisions, or portion or portions of this Ordinance shall be declared invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any remaining provision or provisions, portion or portions.

**SECTION 4.** That all ordinances or parts of ordinances conflicting with any of the provisions of this Ordinance shall be and the same is hereby repealed.

**SECTION 5.** That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

**SECTION 6.** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
