**ORDINANCE NO. O-10-23-05**

**AN ORDINANCE CHANGING THE NAME OF N. KINZIE AVENUE AND S. KINZIE AVENUE WITHIN THE CORPORATE BOUNDARIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS**

**WHEREAS**, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, pursuant to Section 11-80-19 of the Illinois Municipal Code (65 ILCS 5/11-80-19), the Corporate Authorities of the Village are authorized to change the name of any street, avenue, alley, or other public place under the Village's jurisdiction and/or within the Village's corporate boundaries; and

**WHEREAS**, N. Kinzie Avenue and S. Kinzie Avenue (also commonly known as Illinois State Route 50) are avenues located within the corporate boundaries of the Village; and

**WHEREAS**, the Corporate Authorities of the Village have determined that it is necessary and in the best interests of the Village and its citizens to rename N. Kinzie Avenue and S. Kinzie Avenue as set forth in this Ordinance.

**NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** N. Kinzie Avenue, a public right of way located within the Village's corporate boundaries and lying generally between E 6000 N Road to the North and E. Broadway Street to the South, is hereby renamed to N. Bradley Boulevard.

**SECTION 3.** S. Kinzie Avenue, a public right of way located within the Village's corporate boundaries and lying generally between E. Broadway Street to the North and Soldier Creek to the South, is hereby renamed to S. Bradley Boulevard.

**SECTION 4.** The Village Clerk is hereby authorized and directed to provide the election authorities having jurisdiction over the roads renamed by this Ordinance, all post office branches serving said area, and all appropriate 911 and emergency agencies operating within the Village and the surrounding area, with written notice of the name changes affected hereby by certified or registered mail. The name changes made by this ordinance shall not take effect until thirty (30) days after such notice has been provided as required by law. Once said name changes have taken effect, Village Staff are hereby authorized and directed to undertake any and all actions necessary to indicate the new names of said roads with appropriate signage.

**SECTION 5.** All officers, employees, and/or agents of the Village are hereby authorized and directed to undertake any and all actions, including the execution and delivery of any and all documents, necessary and expedient to effectuate the intent of this Ordinance.

**SECTION 6.** The Village Clerk is hereby authorized and directed to publish this Ordinance in pamphlet form. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

**SECTION 7.** All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed, but only to the extent necessary to avoid the conflict.

**SECTION 8.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 9.** This ordinance shall be entered into the minutes and upon the journals of the Board of Trustees of the Village of Bradley.
