AN ORDINANCE DESIGNATING THE INTERSECTIONS OF EAST BROADWAY STREET AND MADISON AVENUE , IN THE VILLAGE OF BRADLEY, AS STOP INTERSECTIONS

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, Section 11-80-2 of the Illinois Municipal Code (65 ILCS 5/11-80-2) authorizes the Corporate Authorities of the Village to regulate the use of the streets and other municipal property under the Village's jurisdiction; and

WHEREAS, Section 11-208(6) of the Illinois Vehicle Code (625 ILCS 5/11-208(6)) further authorizes the Corporate Authorities of the Village, through the exercise of the Village's police powers, to designate any intersection under the Village's jurisdiction as a stop intersection and require all vehicles to stop at one or more entrances to such intersections; and

WHEREAS, the Village has jurisdiction over the intersection of East Broadway Street and Madison Avenue in the Village of Bradley (the "East Broadway Intersection"); and

WHEREAS, the Village has jurisdiction over the intersection of East Broadway Street and Madison Avenue in the Village of Bradley (the "Madison Intersection"); and

WHEREAS, the Corporate Authorities of the Village have determined that it is necessary for public health, safety, and welfare to require vehicles to stop before entering the East Broadway Intersection from both (i) Eastbound and Westbound on East Broadway Street and (ii) southbound South and Northbound on Madison Avenue; and

NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. The Corporate Authorities hereby declare that the East Broadway Street Intersection is and shall be a stop intersection. It is and shall hereinafter be unlawful for any vehicle to enter the East Broadway Street Intersection from (i) Eastbound or Westbound and (ii) southbound and Northbound on Madison Avenue without first stopping as required by law.

SECTION 3. The Chief of Police is hereby authorized and directed to erect or cause the erection of such signs as are necessary to give reasonable notice of the stopping requirements imposed by this Ordinance.

SECTION 4. In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 5. That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

SECTION 6. That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 7. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

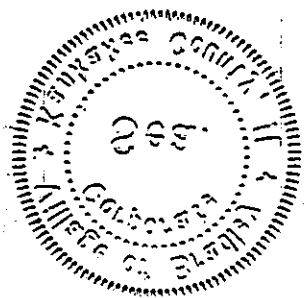

Brief Summary:

The Police Department is seeking to post a stop sign, making the intersection located at East Broadway Street and Madison Avenue's a four way stop intersection. East Broadway Street is a throughway from Bradley Blvd for East and West bound Traffic into the existing subdivisions. The Bradley Police Department has had several complaints of speeders in this area and has prompted a safety concern due to several designated school bus stops, along with a public park and a handicap facility on East Broadway Street and adjoining streets within the residential area.
