**ORDINANCE NO. O-4-15-6**

**AN ORDINANCE AMENDING CHAPTER 2, SECTION 27(A) OF  
THE VILLAGE OF BRADLEY CODE OF ORDINANCES  
REGARDING STANDING COMMITTEES**

**NOW, THEREFORE, IT IS HEREBY ORDAINED** by the President and the Trustees of the Village of Bradley, Kankakee County, Illinois:

**Section 1. Amendment to the Code of Ordinances.** Chapter 2 (Administration), Section 27 (Committees), subsection (a) of the Village of Bradley Code of Ordinances is hereby amended as follows:

**Sec. 2-27. - Committees.**

(a) The following shall be the standing committees of the board of trustees:

- (1) ~~Building maintenance~~ Broadway Redevelopment.
- (2) Insurance, finance and appropriations.
- (3) License, zoning, planning and grants.
- (4) Ordinance and technology.
- (5) Police and fire.
- (6) Public works and parks.
- (7) Utilities/expansion.
- (8) Board of local improvements.

**Section 2. Severability and Repeal of Inconsistent Ordinances.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All existing ordinances of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

**Section 3. Effective Date.** The Clerk of the Village of Bradley shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form and this Ordinance shall take effect upon its approval and publication in pamphlet form as so certified.
