**AN ORDINANCE AMENDING THE VILLAGE OF BRADLEY CODE OF
ORDINANCES TO AUTHORIZE THE TRUSTEES TO EXAMINE THE BOOKS
RECORDS AND PAPERS OF THE VILLAGE**

WHEREAS, the Village of Bradley (the "Village") is an Illinois non-home rule municipal corporation located in Kankakee County, Illinois, organized and operating pursuant to the Constitution and laws of the State of Illinois;

WHEREAS, the Trustees may, from time-to-time, have a need to review the books records and papers of the village; and

WHEREAS, the Village currently code is currently silent on allowing Board Members to view and review such documents and records; and

WHEREAS, the Corporate Authorities have determined that it is in the best interests of the Village to empower the Trustees of the Village Board to examine and inspect the books, records, and papers of the village.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Bradley, Kankakee County, Illinois, as follows:

SECTION 1. RECITALS.

That the foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

SECTION 2. EXAMINATION OF RECORDS.

Chapter 2 ("Administration"), Article II ("Board of Trustees"), Division 1 of the Village Code of the Village of Bradley shall be, and hereby is, amended by adding section

2-45 EXAMINATION OF RECORDS

Trustees of the village at all times may examine and inspect the books, records, and papers of any elected official, agent, employee, appointee, or officer of the village. This section shall be applied retrospectively and prospectively.

SECTION 3. RESOLUTION OF CONFLICTS.

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4. SAVING CLAUSE.

If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.

SECTION 5. EFFECTIVENESS.

This Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
