ORDINANCE ABATING THE TAX HERETOFORE LEVIED FOR THE TAX YEAR 2018 TO PAY THE PRINCIPAL AND INTEREST ON \$4,750,000 GENERAL OBLIGATION SEWERAGE REFUNDING BONDS (ALTERNATE REVENUE SOURCE), SERIES 2015A, OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS

WHEREAS, the President and Board of Trustees of the Village of Bradley have previously adopted the Annual Tax Levy Ordinance of the Village of Bradley, Kankakee County, Illinois for the fiscal year beginning May 1, 2019 and ending April 30, 2020; and

WHEREAS, said Tax Levy Ordinance NO. 0-11-18-2 incorrectly included a levy of \$400,550 for debt service for tax year 2018 on \$4,750,000 General Obligation Sewerage Refunding Bonds (Alternative Revenue Source), Series 2015A; and

WHEREAS, said Tax Levy Ordinance should have stated \$397,900 for debt service on \$4,750,000 General Obligation Sewerage Refunding Bonds (Alternate Revenue Source), Series 2015A; and

WHEREAS, the President and Board of Trustees of said Village are now desirous of abating all of said levy set forth therein, said abatement to be the total amount of \$397,900.00.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS:

SECTION ONE: That the County Clerk of Kankakee be and he is hereby authorized and directed to make a tax abatement in the amount of \$397,900.00 for the tax year 2018 as follows:

<u>TAX LEVY</u>	<u>AMOUNT HEREBY ABATED</u>
Principal and Interest – General Obligation Sewerage Refunding Bonds (Alternate Revenue Source), Series 2015A	\$397,900.00

SECTION TWO: That a certified copy of this Ordinance shall be filed by the Village Clerk of the Village of Bradley with the County Clerk of Kankakee in apt time to effectuate such tax abatement.

SECTION THREE: That the Village Clerk of the Village of Bradley be and is hereby directed to publish this Ordinance in pamphlet form, pursuant to the Statutes of the State of Illinois, made and provided.

SECTION FOUR: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

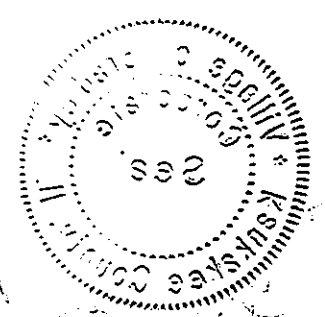
