ORDINANCE NO. 0-6-20-3

AN ORDINANCE AMENDING CHAPTER 18 (FEES AND OTHER CHARGES), SECTION 18-1 (FEES) OF THE VILLAGE OF BRADLEY CODE OF ORDINANCES

---

**WHEREAS**, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, pursuant to Section 11-6-1.1 of the Illinois Municipal Code (65 ILCS 5/11-6-1.1), the Village of Bradley may fix, charge, and collect firefighting service fees not exceeding the actual cost of the service for all firefighting services rendered by the municipality against persons, businesses, and other entities that are not residents of the municipality; and

**WHEREAS**, pursuant to Section 11-6-6 of the Illinois Municipal Code (65 ILCS 5/11-6-6), the Village of Bradley may fix, charge, and collect reasonable fees for technical rescue services, which may not exceed the reasonable cost of providing the technical rescue services and may include charges for personnel and equipment costs; and

**WHEREAS**, the Village has previously exercised its authority to fix, charge, and collect firefighting service fees not exceeding the actual cost of the service for all firefighting services rendered by the municipality against persons, businesses, and other entities that are not residents of the municipality and to fix, charge, and collect reasonable fees for technical rescue services; and

**WHEREAS**, the emergency and non-emergency services response activity to motor vehicle accidents continues to increase each year; and

**WHEREAS**, the Village of Bradley Fire Department has investigated different methods to maintain a high level of quality of emergency and non-emergency service capability throughout times of constantly increasing service demands, where maintaining an effective response by the fire department decreases the costs of incidents to insurance carriers, businesses, and individuals through timely and effective management of emergency situations, saving lives and reducing property and environmental damage; and

**WHEREAS**, the Corporate Authorities of the Village have determined that it is necessary and in the best interests of the Village and its citizens to amend its ordinances related to fees for emergency services for motor vehicle accidents provided by the Village.

**NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** Chapter 18 (Fees And Other Charges), Section 18-1 (Fees), subsection 20-66 of the Village Of Bradley Code Of Ordinances is hereby deleted in its entirety and in its place, new subsection 20-66 "Emergency response to motor vehicle accidents" attached hereto as Exhibit "A" is hereby inserted in its place.

**SECTION 3.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 4.** That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

**SECTION 5.** That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

**SECTION 6.** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.





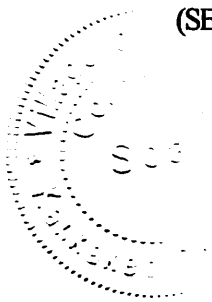
