**ORDINANCE NO. O-8-18-2**

**AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE  
VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS  
(Sanjay P. Patel, PIN: 17-09-16-301-051)**

---

**WHEREAS**, Section 7-1-8 of the Illinois Municipal Code (65 ILCS 5/7-1-8) authorizes the Village to annex any contiguous unincorporated territory provided that no electors reside on said territory or that at least 51% of all electors residing thereon join in the annexation petition; and

**WHEREAS**, Sanjay P. Patel (the "Owner") owns certain property, described in Section 2 of this Ordinance and depicted on Exhibit "A" ("Plat of Annexation"), attached hereto and fully incorporated herein. Said property is hereinafter referred to as the "Annexation Territory"; and

**WHEREAS**, the Annexation Territory is not within the corporate limits of any municipality; and

**WHEREAS**, the Annexation Territory is located in an unincorporated area of Bourbonnais Township, Kankakee County and contiguous to the corporate boundaries of the Village of Bradley; and

**WHEREAS**, no electors reside within the Annexation Territory; and

**WHEREAS**, the Owner has filed a petition with the Village, requesting the Village to annex the Annexation Territory; and

**WHEREAS**, the Village of Bradley provides fire protection services and the Annexation Territory is currently served by the Bourbonnais Fire Protection District; and

**WHEREAS**, the Village does not provide any library services, and as such the Village is not required to provide notice of its intent to annex the Annexation Territory to the Trustees of any Public Library District; and

**WHEREAS**, written notice that the corporate authorities of the Village of Bradley will consider annexation of the Annexation Territory pursuant to Section 7-1-8 of the Municipal Code has been provided as follows:

1. Served by certified mail on the Trustees of the Bourbonnais Fire Protection District not less than ten (10) days prior to passage of this Ordinance at their home addresses; and
2. Published in The Daily Journal on July 28, 2018;

and

**WHEREAS**, an affidavit certifying that service of notice has been provided in compliance with 65 ILCS 5/7-1-1 and all other relevant provisions of the Illinois Municipal Code will be filed with the Recorder of Deeds of Kankakee County; and

**WHEREAS**, the Corporate Authorities of the Village of Bradley hereby find that the annexation of the Annexation Territory complies with all relevant Sections of the Illinois Municipal Code and that such annexation is in the best interests of the Village.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BY THE BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** That the President and Board of Trustees hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct and complete, and further declare that the same are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** That the Annexation Territory, depicted on the Plat of Annexation attached hereto as Exhibit "A" and legally described as:

**TRACT 1:** A TRACT OF LAND DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTHEAST CORNER OF THE SOUTHWEST QUARTER OF SECTION 16, TOWNSHIP 31 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN KANKAKEE COUNTY, ILLINOIS; THENCE SOUTH 2 DEGREES 00 MINUTES EAST ALONG THE EAST LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 16, 1138.5 FEET TO THE INTERSECTION OF SAID LINE WITH THE NORTHEASTERLY RIGHT OF WAY LINE OF RAMP "G" OF THE PROPOSED ROUTE 54 INTERCHANGE; THENCE NORTH 50 DEGREES 01 MINUTES WEST ALONG SAID RIGHT OF WAY LINE, 746.7 FEET TO A POINT; THENCE NORTH 10 DEGREES 15 MINUTES WEST ALONG SAID RIGHT OF WAY LINE, 333.5 FEET TO A POINT; THENCE NORTH 1 DEGREE 46 MINUTES WEST ALONG SAID RIGHT OF WAY LINE 164.85 FEET TO A POINT; THENCE NORTH 32 DEGREES 45 MINUTES WEST, 165.9 FEET TO A POINT ON THE NORTH LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 16; THENCE NORTH 87 DEGREES 47 MINUTES EAST, 695.17 FEET TO THE PLACE OF BEGINNING:

**SECTION 3.** That the Village President shall, within thirty (30) days of the passage of this Ordinance, (1) record with the Recorder of Deeds of Kankakee County, Illinois, (2) file with the County Clerk of Kankakee County, (3) provide to the election authorities having jurisdiction over the Annexation Territory, and (4) provide to all post office branches serving said Annexation Territory:

- a. A certified copy of this Ordinance; and
- b. A Plat of Annexation as required by law, said plat to be attached to the certified copy of this Ordinance as Exhibit "A"; and
- c. An affidavit certifying that service of notice regarding this Ordinance was properly provided in compliance with 65 ILCS 5/7-1-1.

**SECTION 4.** That in the event that any section, paragraph, clause, or provision of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way effect or impair the validity or enforceability of any of the remaining sections, paragraphs, clauses, or provisions of this Ordinance that may be given effect without such invalid or unenforceable section or sections, paragraph or paragraphs, clause or clauses, or provision or provisions.

**SECTION 5.** That all resolutions, ordinances, motions, or parts thereof conflicting with any of the sections, paragraphs, clauses, or provisions of this Ordinance shall be and are hereby repealed to the extent of the conflict.

**SECTION 6.** That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

**SECTION 7.** That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

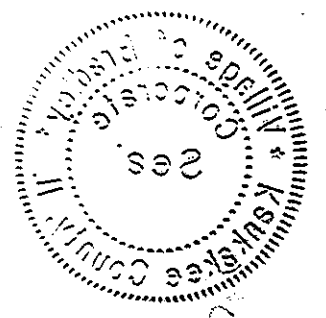
