**ORDINANCE NO. O-8-19-3**

**AN ORDINANCE AMENDING CHAPTER 54 (UTILITIES), ARTICLE III (SEWER SERVICE), DIVISION 4 (DISCHARGES), SECTION 54-174 (USE OF PUBLIC SEWERS)**

**WHEREAS**, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, the Corporate Authorities of the Village previously enacted certain restrictions on the use of the Village's public sanitary sewers; and

**WHEREAS**, the Kankakee River Metropolitan Agency ("KRMA") recently adopted additional discharge restrictions (the "Restrictions") for the sanitary sewer systems under its jurisdiction, including the Village's system; and

**WHEREAS**, KRMA has indicated that the Restrictions are necessary for compliance with applicable EPA regulations; and

**WHEREAS**, the Corporate Authorities of the Village have determined that amending the Village's sewer discharge restrictions to include provisions functionally identical to the Restrictions is in the best interests of the Village and its citizens.

**NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** That Chapter 54 (Utilities), Article iii (Sewer Service), Division 4 (Discharges), Section 54-174 (Use Of Public Sewers) of the Bradley Village Code is hereby amended to include the following:

**Sec. 54-174. - Use of public sewers.**

(d) No person shall discharge or cause to be discharged any of the following described waters or wastes to any public sewers:

\* \* \*

(5) Any bulk, expired, outdated, or concentrated prescription or non-prescription drugs;  
or

(6) Any hazardous waste pharmaceuticals or DEA controlled substances to the POTW by a healthcare facility or reverse distributor pursuant to 40 CFR §266.505.

**SECTION 3.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 4.** That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

**SECTION 5.** That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

**SECTION 6.** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
