**AN ORDINANCE REPEALING THE SIMPLIFIED MUNICIPAL
TELECOMMUNICATIONS TAX OF THE VILLAGE OF BRADLEY, KANKAKEE
COUNTY, ILLINOIS**

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, on September 10, 2018, the Corporate Authorities passed Ordinance No. O-9-18-1, which imposed a simplified telecommunications tax upon the citizens and residents of the Village of Bradley, Kankakee County, Illinois (the “Telecom Tax”), pursuant to the statutory authority provided by the Simplified Municipal Telecommunications Tax Act (35 ILCS 636/5-1, *et seq.*); and

WHEREAS, the Corporate Authorities have since determined that the Telecom Tax is not necessary and expedient to serve the legitimate corporate purposes of the Village; and

WHEREAS, the Corporate Authorities have determined that repealing the Telecom Tax is in the best interests of the Village and its citizens.

NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. That Ordinance No. O-9-18-1 (“An Ordinance Imposing A Simplified Municipal Telecommunications Tax”) is hereby repealed, along with the Telecom Tax imposed thereby, which shall no longer be assessed or collected.

SECTION 3. That the Village Clerk is hereby directed to file a certified copy of this Ordinance with the Illinois Department of Revenue on or before September 20, 2019.

SECTION 4. That in the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 5. That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

SECTION 6. That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION 7. That this Ordinance shall be in full force and effect on January 1, 2020.

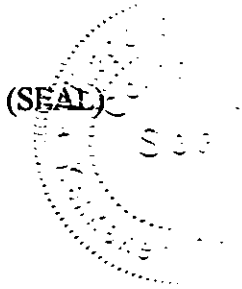
