**ORDINANCE NO. O-9-15-4**

**AN ORDINANCE AMENDING CHAPTER 4 (“ALCOHOLIC BEVERAGES”), ARTICLE III (“LICENSES”), SECTION 4-77 (“NUMBER OF LICENSES”) OF THE CODE OF ORDINANCES OF THE VILLAGE OF BRADLEY**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, Kankakee County, Illinois, as follows:**

**Section 1. Village Code Amended.** Chapter 4 (“Alcoholic Beverages”), Article III (“Licenses”), Section 4-77 is hereby amended by deleting the overstricken language and adding the underlined to read as follows:

**Sec. 4-77. Number of licenses.**

**Section 2. Severability and Repeal of Inconsistent Ordinances.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All existing ordinances of the Village of Bradley are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.





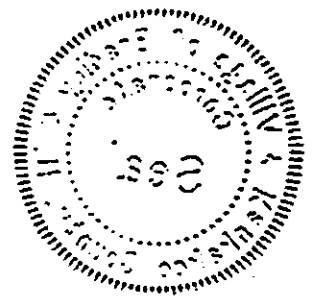
