**ORDINANCE NO. 0-9-18-2**  
**AN ORDINANCE REGARDING FIRE DEPARTMENT**  
**PAID-ON-CALL WAGE RATES**

WHEREAS, the Village of Bradley currently has certain Paid-On-Call Fire Department personnel; and

WHEREAS, the last wage increase for said Paid-On-Call Fire Department personnel was in or around October 13, 2008; and

WHEREAS, the Village believes that it is appropriate to provide an hourly wage increase of 2.25 percent to said Paid-On-Call personnel with this wage increase being applied retroactively back to May 1, 2018; and

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS:

**Section 1.** The Corporate Authorities hereby find that the recitals contained in the preamble are true and correct, and incorporated into this ordinance by reference.

**Section 2.** The following positions shall be paid at hourly wage rates for duties performed as paid-on-call personnel for the Village of Bradley Fire Department, said wages reflecting an increase of 2.25%.

Deputy Fire Chief	\$ 16.60
Captain	\$ 15.09
Lieutenant	\$ 13.72
Engineer	\$ 12.47
Firefighter/Paramedic	\$ 11.88
Firefighter/EMT	\$ 11.60
Firefighter	\$ 11.32
Probationary Firefighter	\$ 8.42

**Section 3. Monthly Stipend.** The current monthly stipend for the positions of Lieutenant, Captain and Deputy Fire Chief shall remain in effect for these positions. The current monthly stipend for the positions of Engineer, Driver and Driver/Operator is eliminated and repealed pursuant to this Ordinance.

**Section 4. Severability and Repeal of Inconsistent Ordinances.** Any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**Section 4. Effective Date.** The Clerk of the Village of Bradley shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form and this Ordinance shall take effect upon approval and publication in pamphlet form as so certified.


