**ORDINANCE NO. O-7-21-5**

**AN ORDINANCE AMENDING CHAPTER 4 (ALCOHOLIC BEVERAGES) OF THE  
BRADLEY VILLAGE CODE TO CREATE A NEW CLASS K1 (POOL HALL) LIQUOR  
LICENSE FOR THE VILLAGE OF BRADLEY**

---

**WHEREAS**, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, pursuant to Section 4-1 of the Illinois Liquor Control Act (235 ILCS 5/4-1), the Corporate Authorities of the Village are authorized, *inter alia*, “to determine the number, kind and classification of licenses, for sale at retail of alcoholic liquor not inconsistent with [the] Act and the amount of the local licensee fees to be paid for the various kinds of licenses to be issued in their political subdivision”; and

**WHEREAS**, the Corporate Authorities of the Village previously exercise the foregoing authority by enacting Chapter 4 (Alcoholic Beverages) of the Bradley Village Code; and

**WHEREAS**, the Corporate Authorities of the Village have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to amend those various provisions of said Chapter 4 (Alcoholic Beverages) addressed in this Ordinance for the purposes of creating a new “Class K1 (Pool Hall)” liquor license within the Village of Bradley.

**NOW THEREFORE, BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:**

**SECTION 1.** The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Ordinance are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

**SECTION 2.** Chapter 4 (Alcoholic Beverages), Article I (In General), Section 4-1 (Definitions) is hereby amended in part to include the following:

**Sec. 4-1. - Definitions.**

\* \* \*

**POOL HALL.** An establishment for which the primary business focus is the operation of a recreational facility in which members of the public play the game commonly known as “pool” or any other game of billiards.

\* \* \*

**SECTION 3.** Chapter 4 (Alcoholic Beverages), Article III (Licenses), Division 1 (In General), Section 4-68 (Classifications and amounts of fees) is hereby amended in part to include the following as a new class of liquor license in the Village of Bradley:

**Sec. 4-68. - Classifications and amounts of fees.**

Licenses shall be and are hereby divided into classes, with fees for such licenses as follows:

**Class K1 (Pool Hall).** Issued to authorize the retail sale of alcoholic liquors for consumption on the licensed premises of a Pool Hall. The licensed premises shall have a minimum of ten (10) functional pool or billiards tables available for use at all times during which alcoholic liquors are sold or offered for sale on the licensed premises. The full amount of the annual license fees for such Class K1 license shall be as set forth in Section 4-77 of this Chapter.

**SECTION 3.** Chapter 4 (Alcoholic Beverages), Article III (Licenses), Division 1 (In General), Section 4-77 (Number of licenses, annual license fees, and automatic license reduction.) is hereby amended in part to include the following:

**Sec. 4-77. - Number of licenses, annual license fees, and automatic license reduction.**

(a) The number of license in each classification, as well as the annual fee for said license, shall be as follows:

Class	Maximum Number of Available Licenses in Class	Annual Fee

Class K1 license (Pool Hall).	1	\$1,200

**SECTION 4.** In the event that any provision or provisions, portion or portions, or clause or clauses of this Ordinance shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Ordinance that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

**SECTION 5.** That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Ordinance, are hereby repealed to the extent of the conflict.

**SECTION 6.** That the Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

**SECTION 7.** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.\
