Applications for refunds will not be processed unless completed in full and submitted with a copy of your paid **2022 property tax bill** which can be found at <http://treasurer.k3county.net>. The Village cannot supply copies of documentation. Failure to provide complete and accurate information will result in the rejection of your application. Applicants should consult a tax professional regarding the taxability of this refund.
