A RESOLUTION FOR MAINTENANCE UNDER THE ILLINOIS HIGHWAY CODE

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, the Corporate Authorities of the Village have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to appropriate motor fuel tax funds in a sum equal to nine hundred thousand and 00/100 dollars (\$900,000.00) for the purposes of maintaining streets and highways under the applicable provisions of the Illinois Highway Code for the period between January 1, 2024, and December 31, 2024.

NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURPUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

<u>SECTION 1.</u> The Corporate Authorities hereby find all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. The Corporate Authorities of the Village hereby appropriate motor fuel tax funds in a sum equal to nine hundred thousand and 00/100 dollars (\$900,000.00) for the purposes of maintaining streets and highways under the applicable provisions of the Illinois Highway Code for the period between January 1, 2024, and December 31, 2024. Only those operations as listed and described on the approved estimate of maintenance costs, including supplemental or revised estimates approved in connection with this Resolution, are eligible for maintenance with motor fuel tax funds during the period as specified above.

SECTION 3. The Village Clerk is hereby authorized and directed to submit a certified statement showing expenditures from and balances remaining in the motor fuel tax funds appropriated by this Resolution to the Illinois Department of Transportation ("IDOT") on such form(s) supplied by IDOT within three months of the maintenance period set our in Section 2 of this Resolution, *supra*.

<u>SECTION 4.</u> The Village Clerk is hereby authorized and directed to trasmit four (4) cerified originals of this Resolution to IDOT's local district office.

SECTION 5. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 6. All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 7. The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 8. This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.


