A RESOLUTION ACCEPTING BID IN CONNECTION WITH THE HILLTOP ROAD RECONSTRUCTION PROJECT

WHEREAS, the Corporate Authorities of the Village of Bradley, Kankakee County, Illinois, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety, and welfare of its citizens; and

WHEREAS, on or around May 20, 2025, the Village published an advertisement for bids for the Hilltop Road Reconstruction Project (the "Project"); and

WHEREAS, the Village opened and reviewed all bids received in relation to the Project on June 9, 2025; and

WHEREAS, the Corporate Authorities of the Village have determined that Kankakee Valley Construction Company, Inc. (KVCC) was the lowest responsible bidder of the respective project; and

WHEREAS, the Corporate Authorities of the Village have determined that it is necessary, expedient, and in the best interests of the Village and its citizens to accept the bid from Kankakee Valley Construction Company, Inc. (KVCC) in the total amount of four hundred five thousand three hundred ninety nine dollars and 34/100 (\$405,399.34) for the Hilltop Road Reconstruction Project (a copy of the bid tabulations is attached hereto as Exhibit A and fully incorporated herein); and

NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

<u>SECTION 1.</u> The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made part hereof.

SECTION 2. The Corporate Authorities of the Village hereby find and declare that the bid received by Kankakee Valley Construction Company, Inc. (KVCC) for the Hilltop Road Reconstruction Project, a copy which is attached hereto as Exhibit A and incorporated herein, is fair, reasonable and acceptable to the Village and hereby awards said contract to Kankakee Valley Construction Company, Inc. (KVCC) for the amount of four hundred five thousand three hundred ninety nine dollars and 34/100 (\$405,399.34).

SECTION 3. The Corporate Authorities of the Village hereby authorize and direct the Village President to take any actions necessary to effectuate the intent of this Resolution, which is to accept the bid for the Project and to award the vendor the contract bid.

SECTION 4. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent

jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

<u>SECTION 5.</u> All ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 6. The Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 7. This Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
