A RESOLUTION APPROVING THE PURCHASE AND INSTALLATION OF POLICE SECURITY CAMERAS

WHEREAS, the Village of Bradley is not a home rule municipality within Article VII, Section 6A of the Illinois Constitution and, pursuant to the powers granted to it under 65 ILCS 5/1-1 et seq.; and,

WHEREAS, police security cameras act as a force multiplier and security measure to the village residents and business corridors; and,

WHEREAS, the Village of Bradley ("the Village") wishes to authorize the purchase and installation of new security cameras; and,

WHEREAS, the Village Board finds that this Resolution protects and promotes the public welfare, safety, health and morals;

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

<u>SECTION 1.</u> SECURITY CAMERA PURCHASE AND INSTALLATION AUTHORIZED

The Police Chief is authorized and directed to execute an agreement with Advanced Computer Specialists, Wireless CCTV and Outsen Electric for the purchase and installation of police security cameras. The Police Chief shall further be authorized and directed to execute any related or supplemental documents, including approval of scopes of work, project timelines or revisions thereto, proposals, or related documents, and is further authorized to serve as project manager and to execute all documents relating to installation.

<u>SECTION 2.</u> The Corporate Authorities hereby waive, by an affirmative vote of two-thirds (2/3) of the trustees presently holding office, any and all competitive bidding requirements as might otherwise be applicable to the purchases authorized by this Resolution.

SECTION 3. In the event that any provision or provisions, portion or portions, or clause or clauses of this Resolution shall be declared to be invalid or unenforceable by a Court of competent jurisdiction, such adjudication shall in no way affect or impair the validity or enforceability of any of the remaining provisions, portions, or clauses of this Resolution that may be given effect without such invalid or unenforceable provision or provisions, portion or portions, or clause or clauses.

SECTION 4. That all ordinances, resolutions, motions, or parts thereof, conflicting with any of the provisions of this Resolution, are hereby repealed to the extent of the conflict.

SECTION 5. That the Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 6. That this Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

Agenda Cover Memorandum

The Village of Bradley Police Department is requesting a waiver to bypass the competitive bidding process. Due to the technical components of the equipment being compatible with our existing Milestone Video software for storage and server space, this item would likely qualify as a sole source provider. If we were to go with another camera system, the Village would need to purchase additional storage hardware which would increase the price of the project exponentially. The Village reached out to two authorized Panasonic dealers and our current IT vendor Advanced Computer Specialist was the cheaper option for the cameras and Wireless CCTV was cheaper option for the mobile security trailer. The installation will be handled by our current electrical vendor Outsen Electric.

Advanced Computer Systems (Cameras): \$43,500 Wireless CCTV (Mobile Security Trailer): \$24,708

Outsen Electric (Installation): \$28,750

- 2.3 WCCTV shall use reasonable efforts to deliver the Equipment within a reasonable time but it shall not incur any liability in the event of any delay
- 2.4 Placement of Your order constitutes acceptance of these Terms and Conditions and Your agreement to pay the prices set forth herein for the Equipment/Service ordered. Term: Cancellation of Service

- 3.1 if You purchase Equipment which includes airtime, You agree to a minimum fixed term of 12, 24 or 36 months (the "Fixed Term") as involced by WCCTV. The Fixed Term and any subsequent 3.1 if You purchase Equipment which includes airtime, You agree to a minimum fixed term of 12, 24 or 36 months (the "Fixed Term") as invoiced by WCCTV. The Fixed Term and any subsequent term are collectively referred to as the "Term". You are bound by these Terms and Conditions for the full Term. Your obligation to pay for Equipment and Services already purchased shall continue regardless of termination.

Charges

- 4.1 You will pay all the charges for all usage of the Equipment, including, but not limited to, charges for data used in connection with the Equipment after delivery and any other charges for Service ("Usage Charges") as provided in Section 4.3 below. Certain usage charges may be included in the price of the Equipment, if stated in this Proposal and certain Usage Charges are not included in the price of the Equipment. Rates specified shall apply only during the Fixed Term, unless notified in writing by WCCTV of an increase. WCCTV may increase the usage rates at any time, as and when it deems appropriate, subject to Your rights to cancel as provided in Section 3.2.
- 4.2 You will pay for all additional gigabytes in full gigabyte increments, with partial gigabytes rounded to the next full gigabyte
