RESOLUTION NO. R-10-19-2

A RESOLUTION AUTHORIZING BRADLEY DG, LLC, TO APPLY FOR A PERMIT FROM IDOT AUTHORIZING CERTAIN WORK WITHIN THE CORPORATE BOUNDARIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS

WHEREAS, Bradley DG, LLC (“Bradley DG”), owns certain property within the corporate boundaries of the Village and said property abuts State Route 50, which comes under the jurisdiction and control of the Illinois Department of Transportation (“IDOT”);

WHEREAS, Bradley DG wishes to construct a commercial access entrance to connect Bradley DG’s property to the State’s Route 50 right-of-way (the “Project”); and

WHEREAS, Bradley DG must receive a permit from IDOT before it can begin work on the Project; and

WHEREAS, IDOT will not issue Bradley DG said permit unless the Village passes a resolution stating that the Village is aware of the project and that the Village has no objection to said Project; and

WHEREAS, the Village is aware of the Project; and

WHEREAS, the Village has no objection to the Project; and

WHEREAS, the Village shall have no obligation to take any other action or make any payment with regards to the Project because all such actions will be taken and all necessary payments shall be made by Bradley DG alone; and

WHEREAS, the Village President and Board of Trustees have determined that passing a resolution authorizing Bradley DG to apply for and receive a permit from IDOT that, in turn, authorizes Bradley DG to begin work on the Project is in the best interests of the citizens of the Village.

NOW THEREFORE, BE IT RESOLVED BY THE CORPORATE AUTHORITIES OF THE VILLAGE OF BRADLEY, KANKAKEE COUNTY, ILLINOIS, PURSUANT TO ITS STATUTORY AUTHORITY, AS FOLLOWS:

SECTION 1. The Corporate Authorities hereby find that all of the recitals contained in the preamble to this Resolution are true, correct, and complete and are hereby incorporated by reference hereto and made a part hereof.

SECTION 2. That the Village President and Board of Trustees are aware of the Project, as well as Bradley DG’s need for a permit from IDOT authorizing the Project.

SECTION 3. That the Village President and Board of Trustees hereby state and affirm that the Village has no objection to the Project.

SECTION 4. That the Village President and Board of Trustees hereby authorize Bradley DG to apply for and receive a permit from IDOT authorizing Bradley DG to begin work on the Project.

SECTION 5. That nothing in this Resolution shall be interpreted as imposing any obligation upon the Village to take any other action or make any payment with regards to the Project.

SECTION 6. That the Village Clerk is hereby directed to publish this Resolution in pamphlet form.

SECTION 7. That this Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
